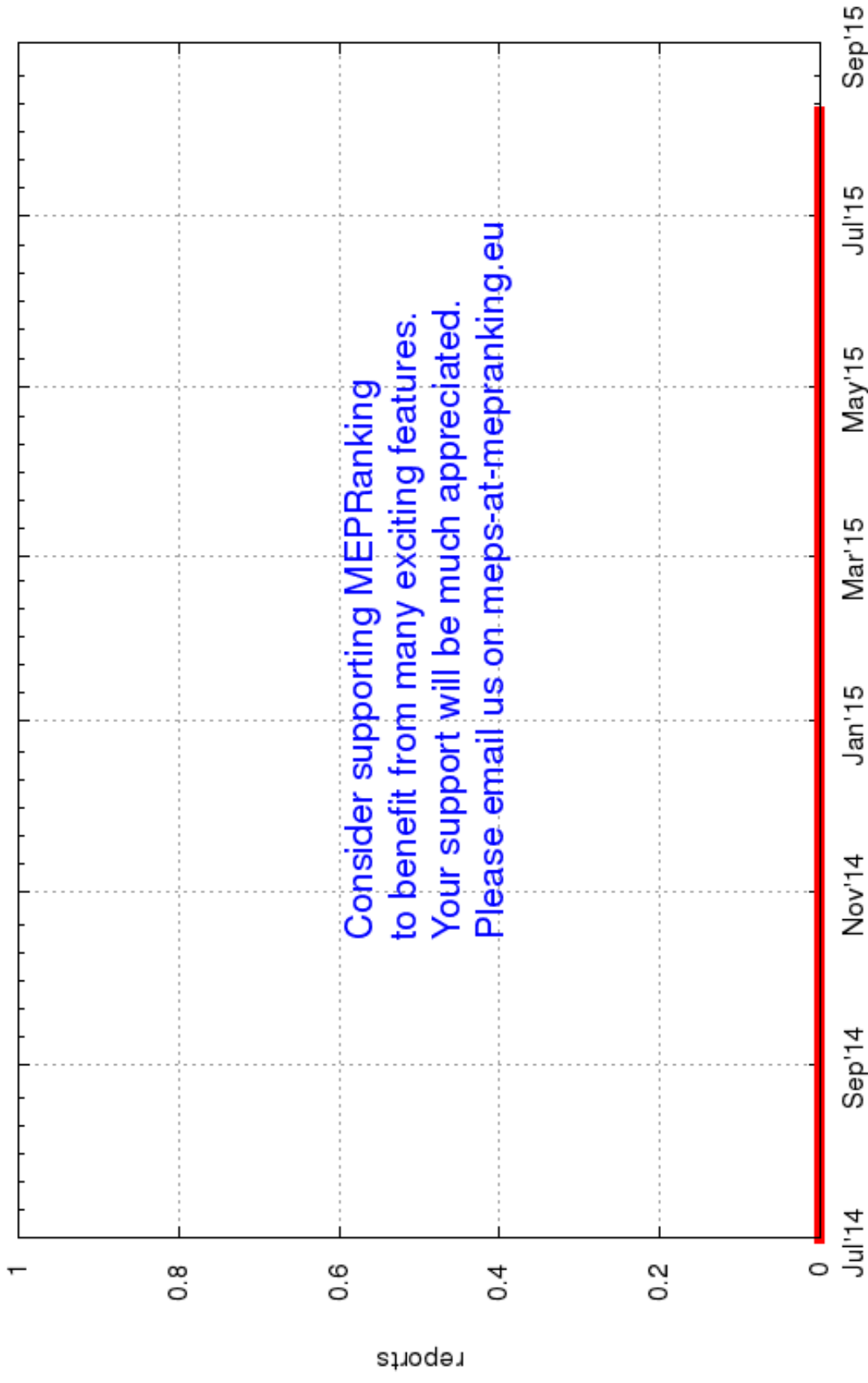

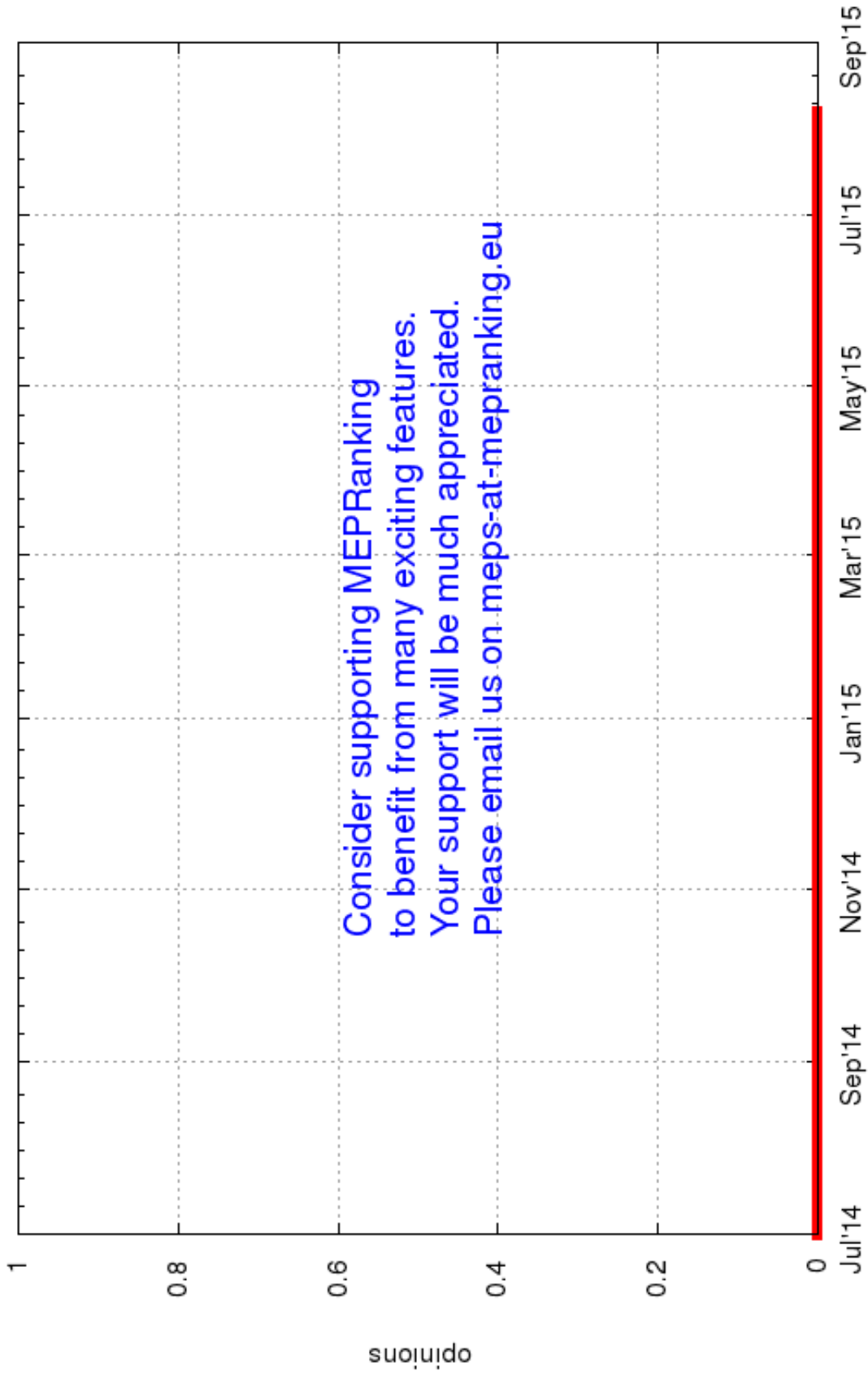
MOTIONS of Steeve BRIOIS in the EP (8th term)



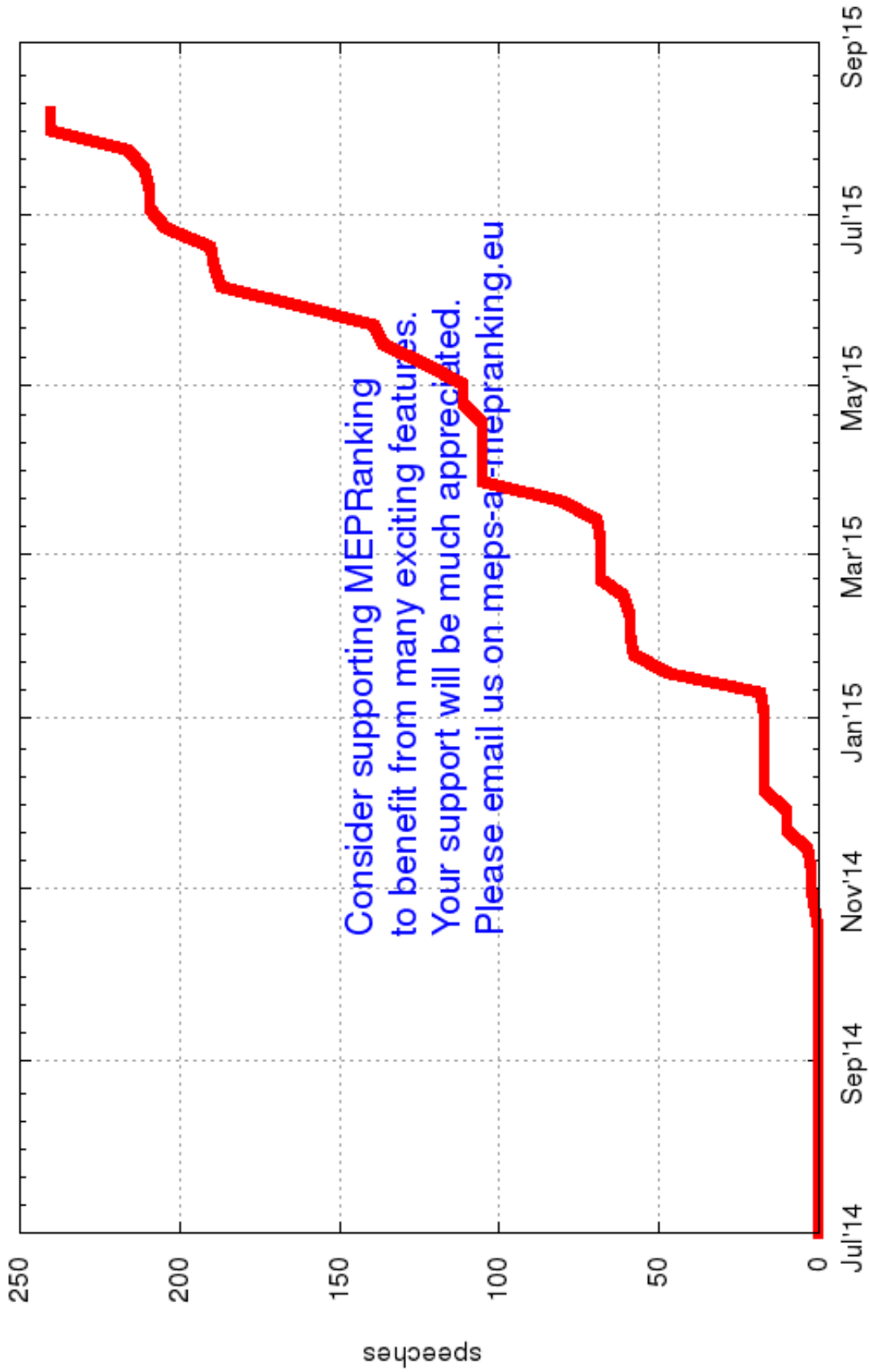

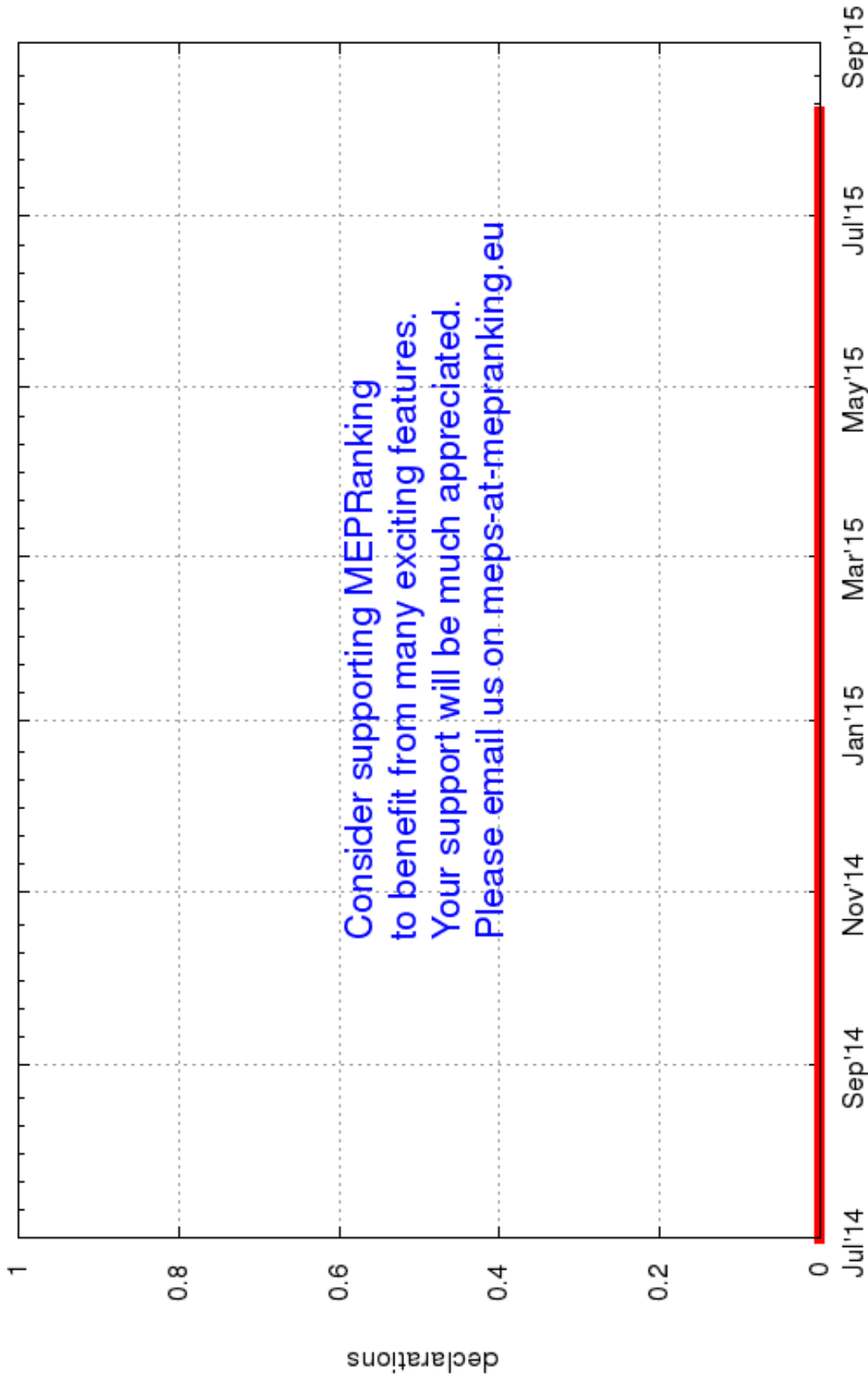

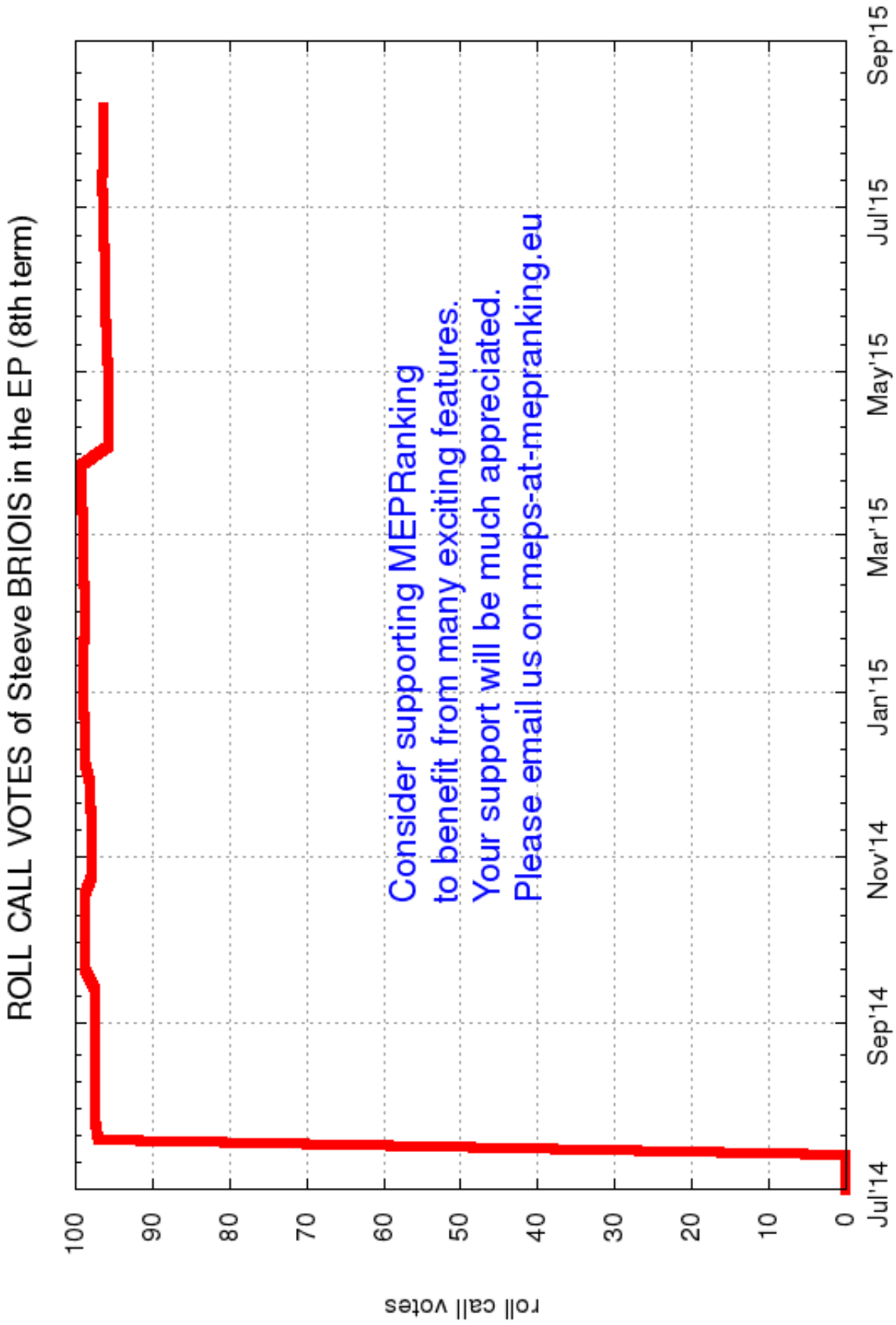
