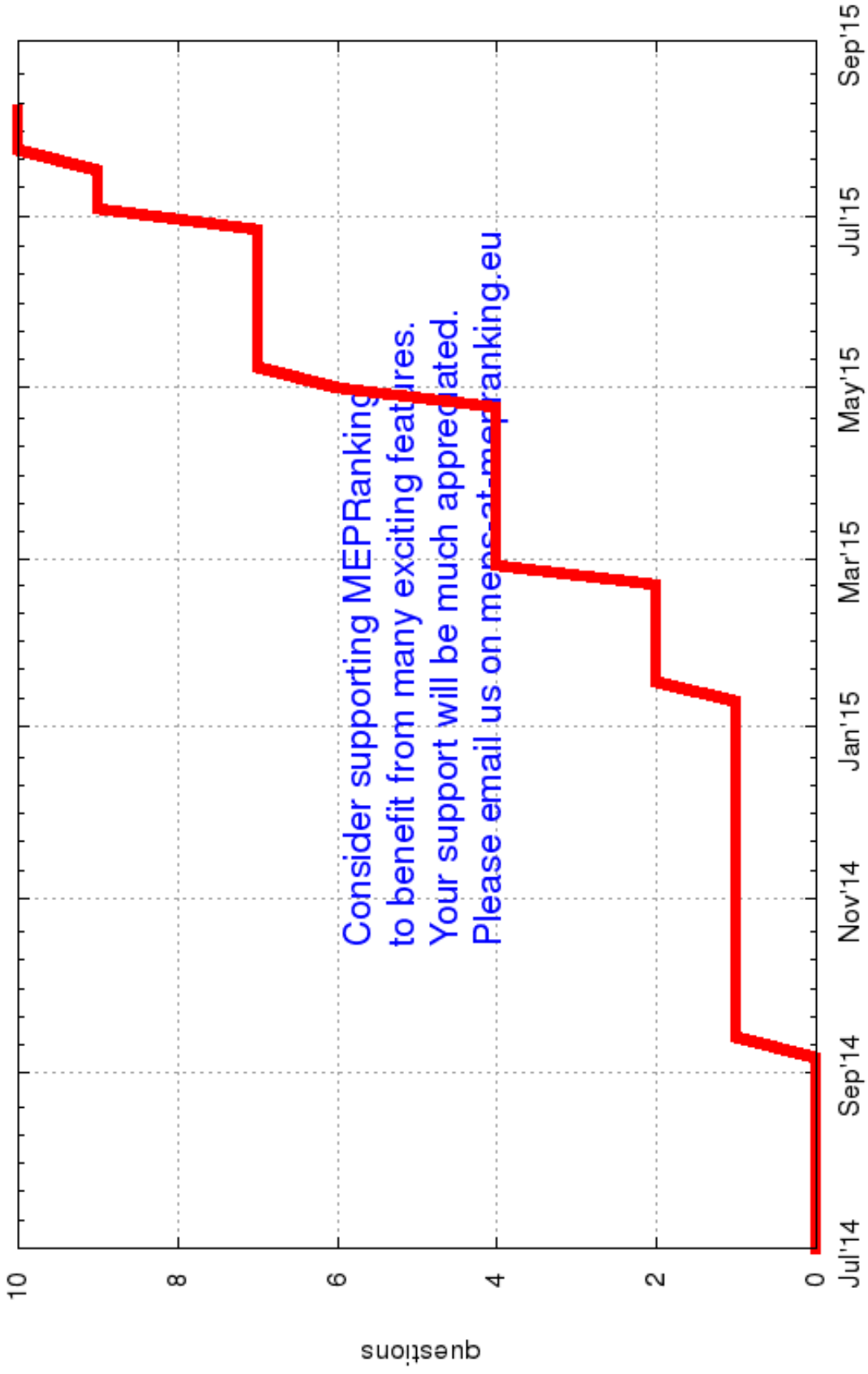

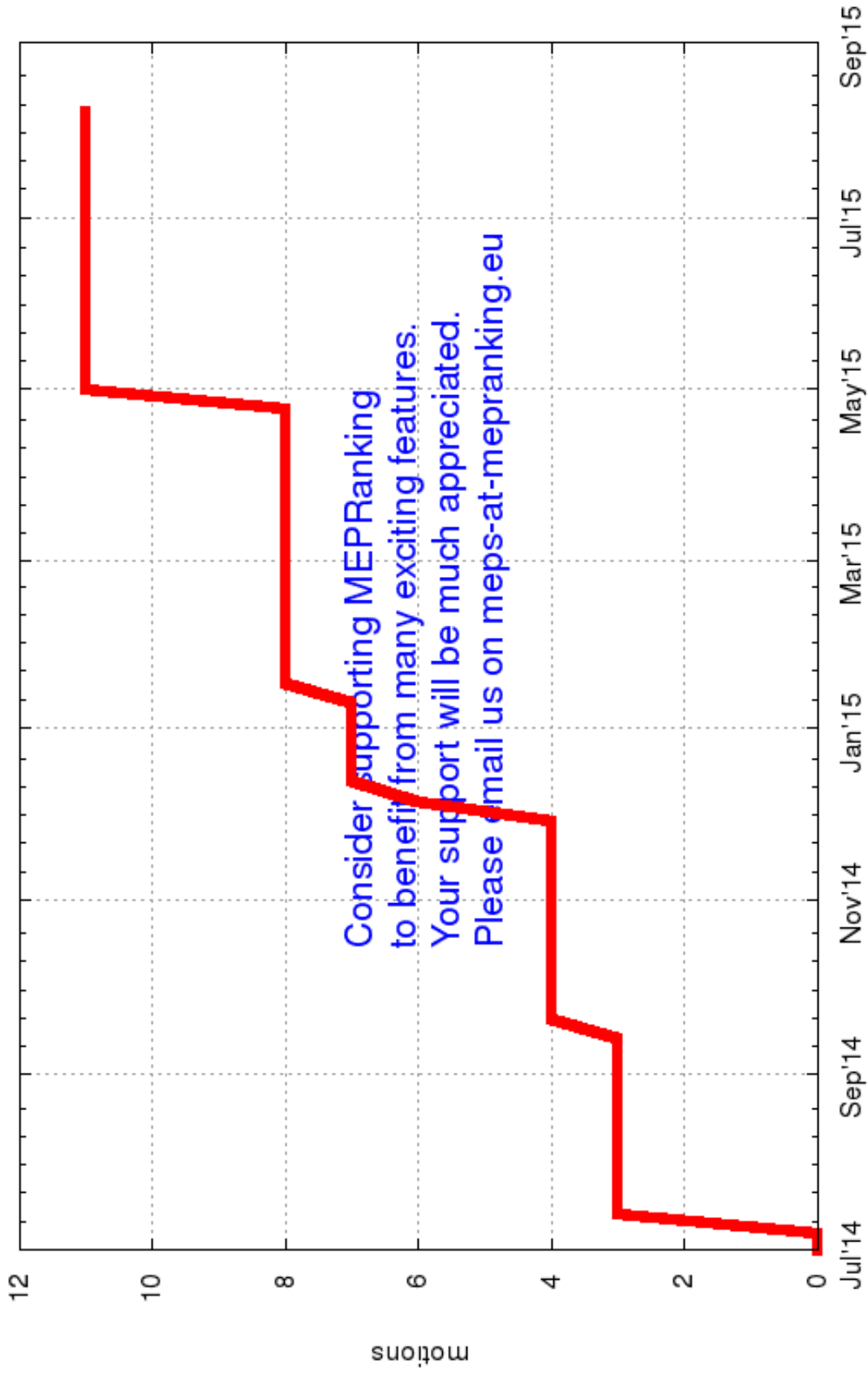

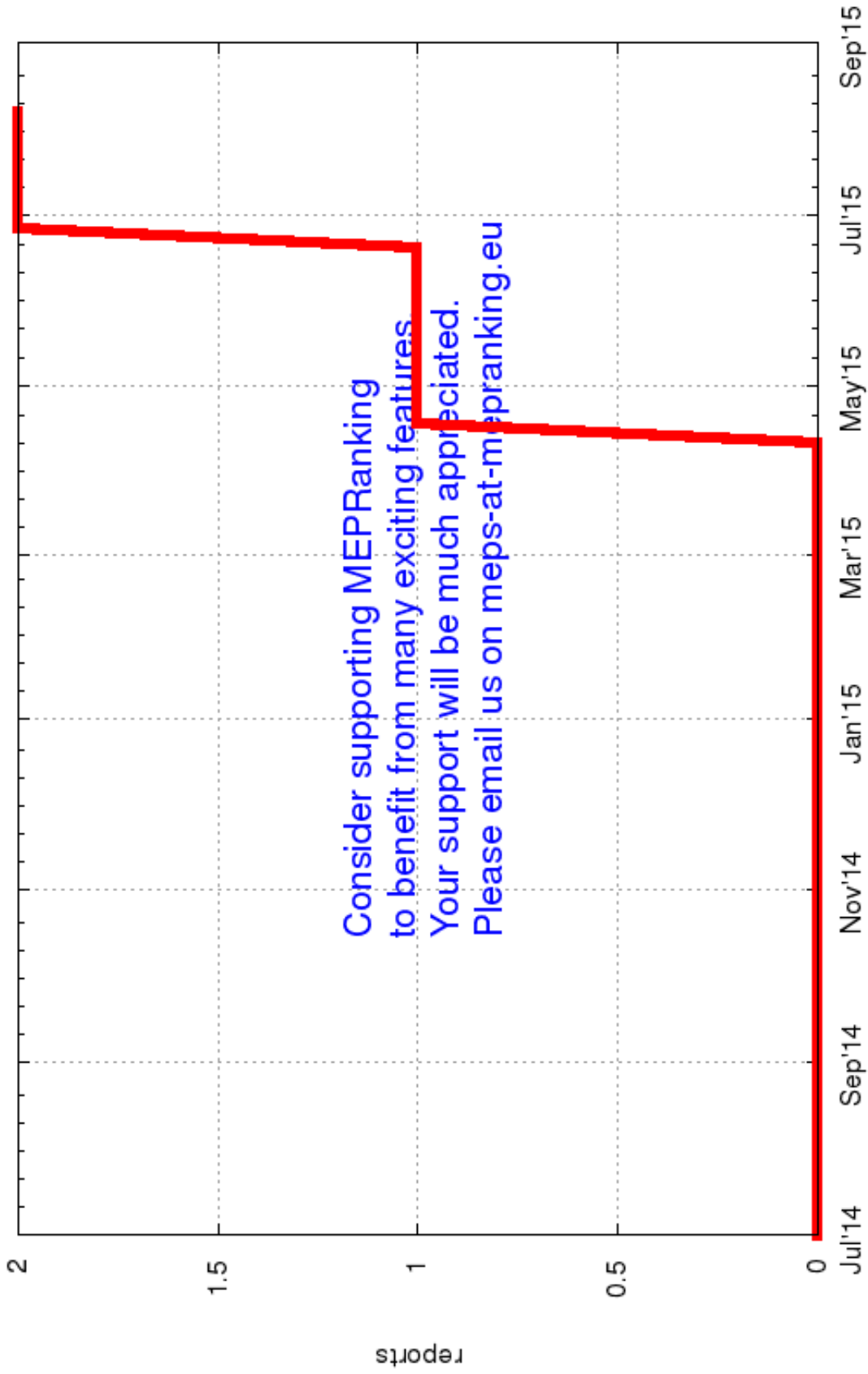

MOTIONS of Klaus BUCHNER in the EP (8th term)

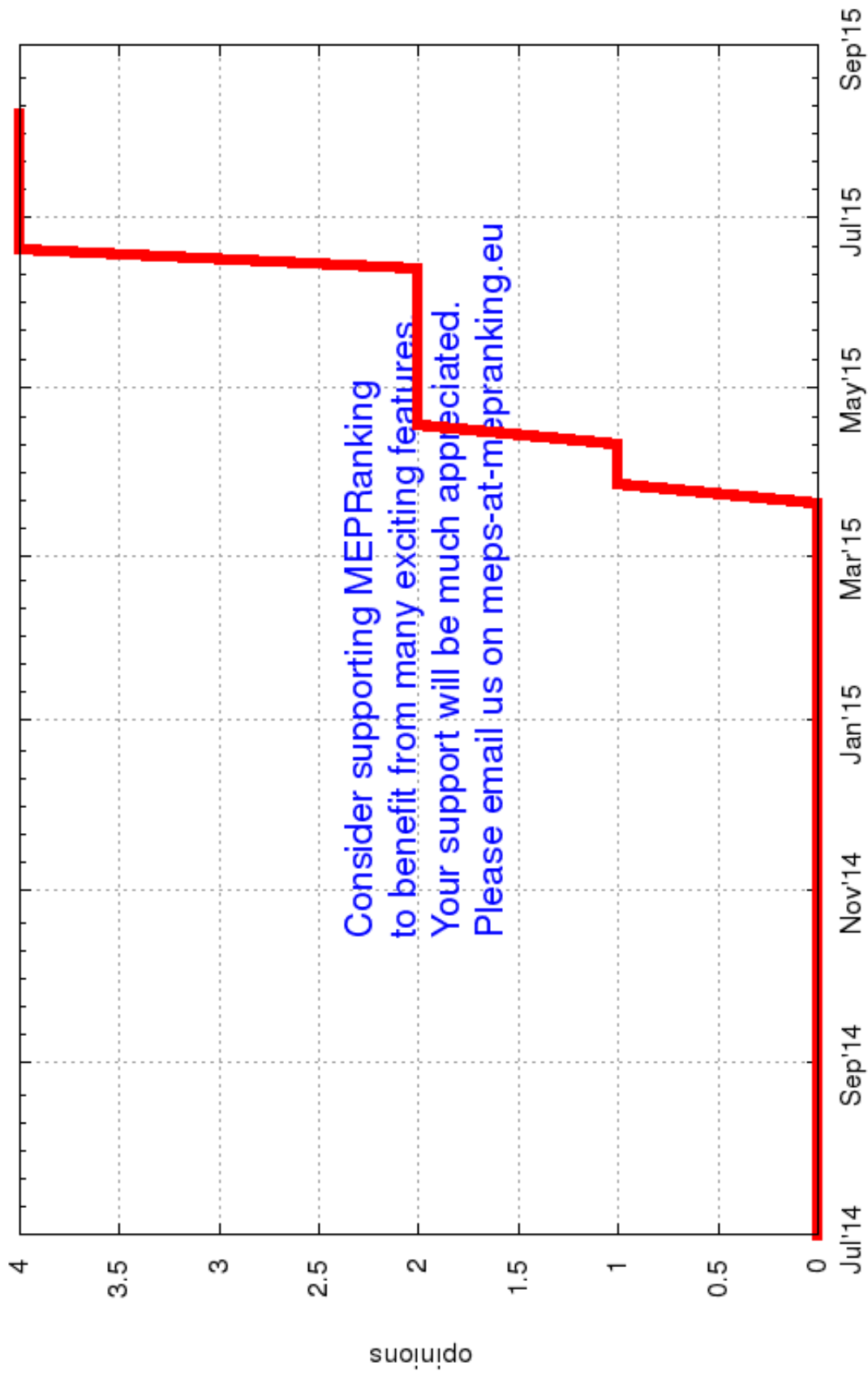

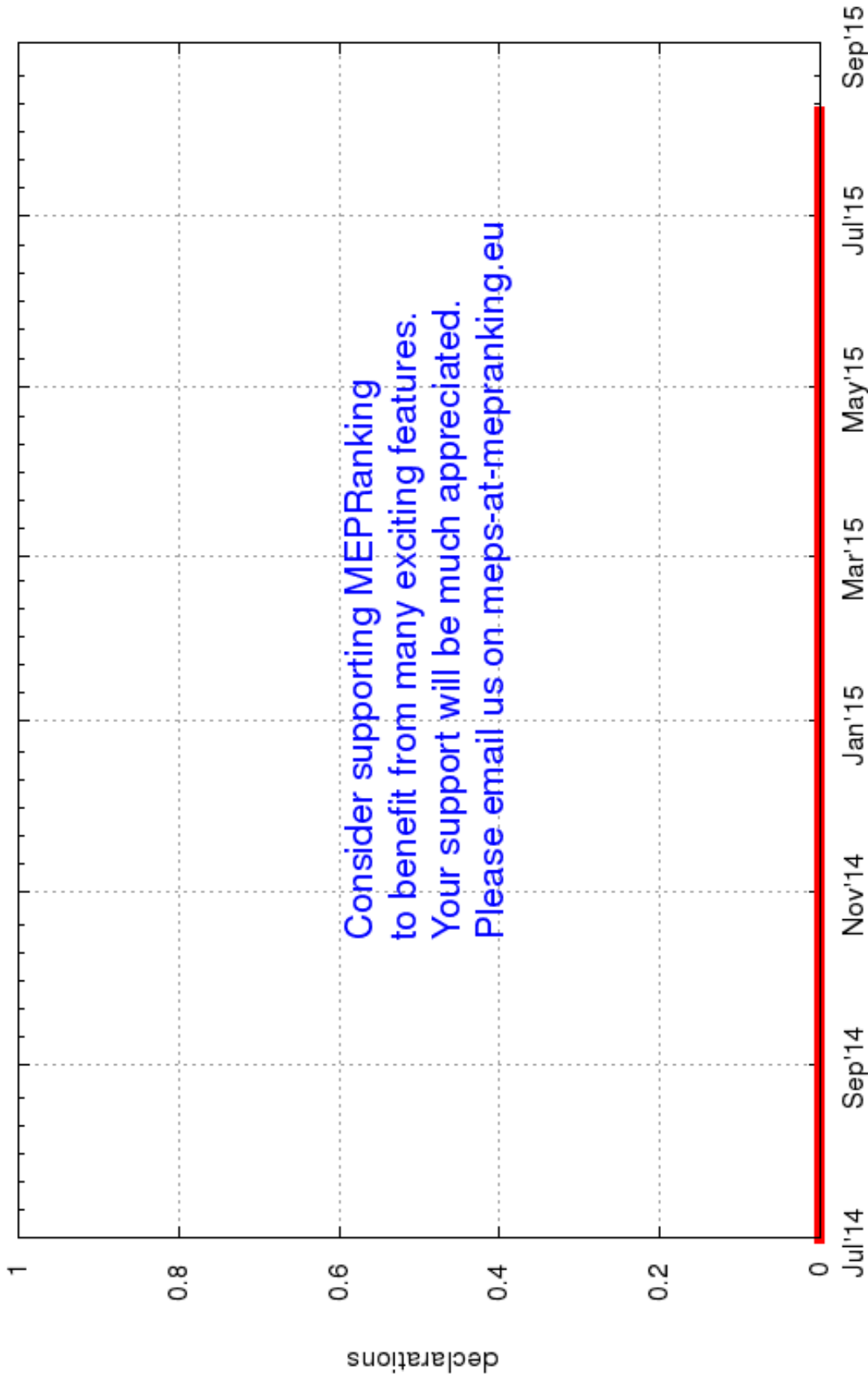

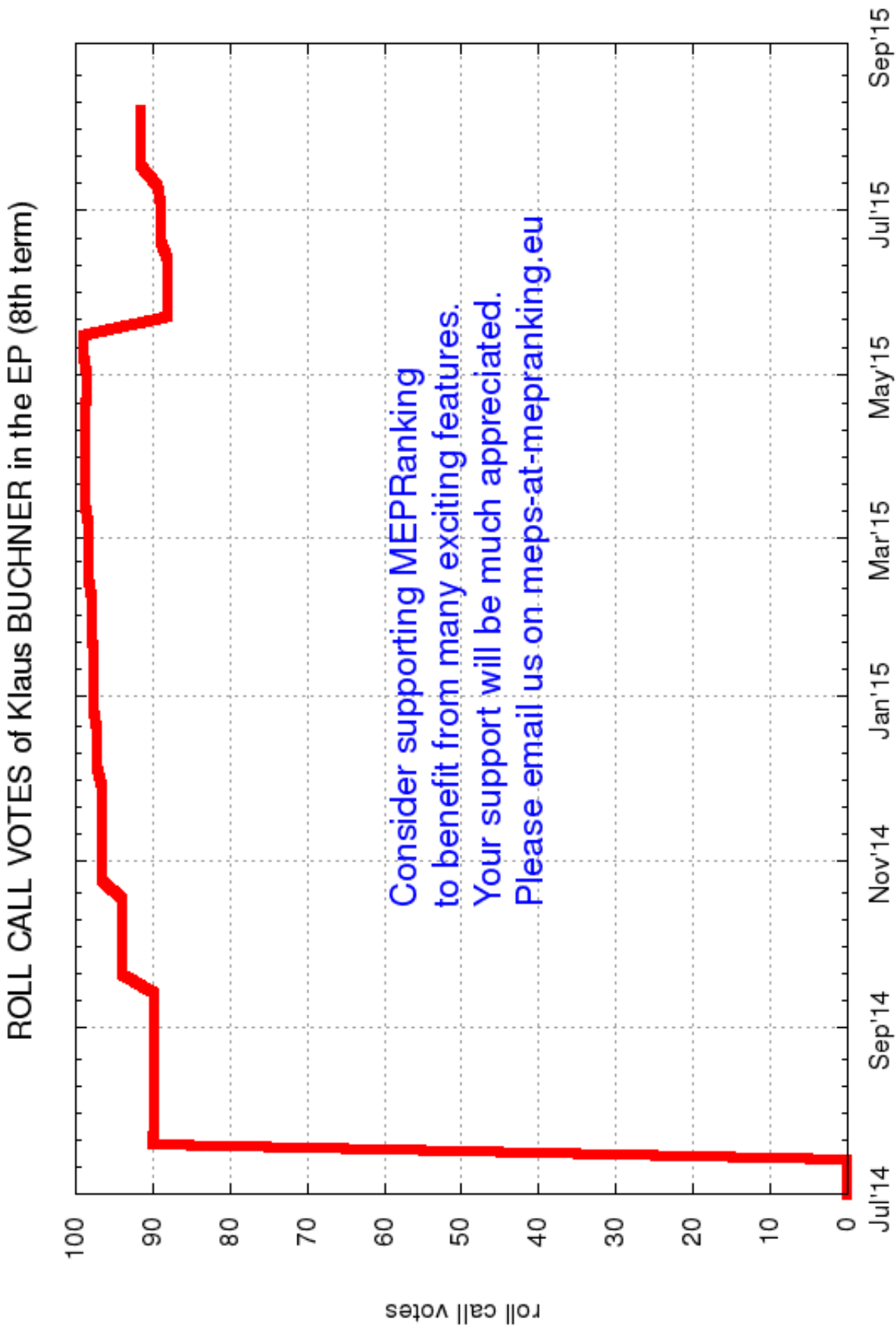
