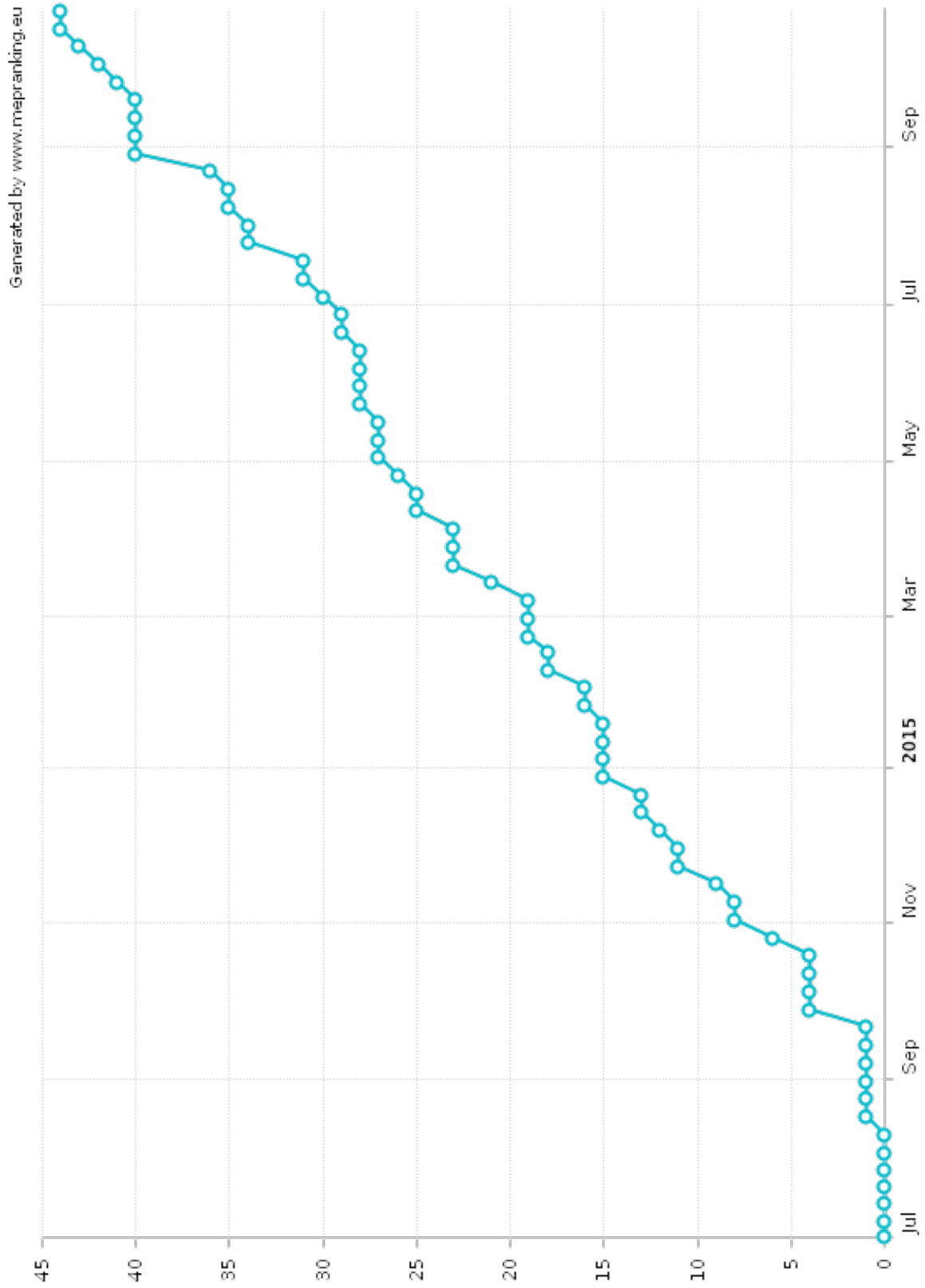

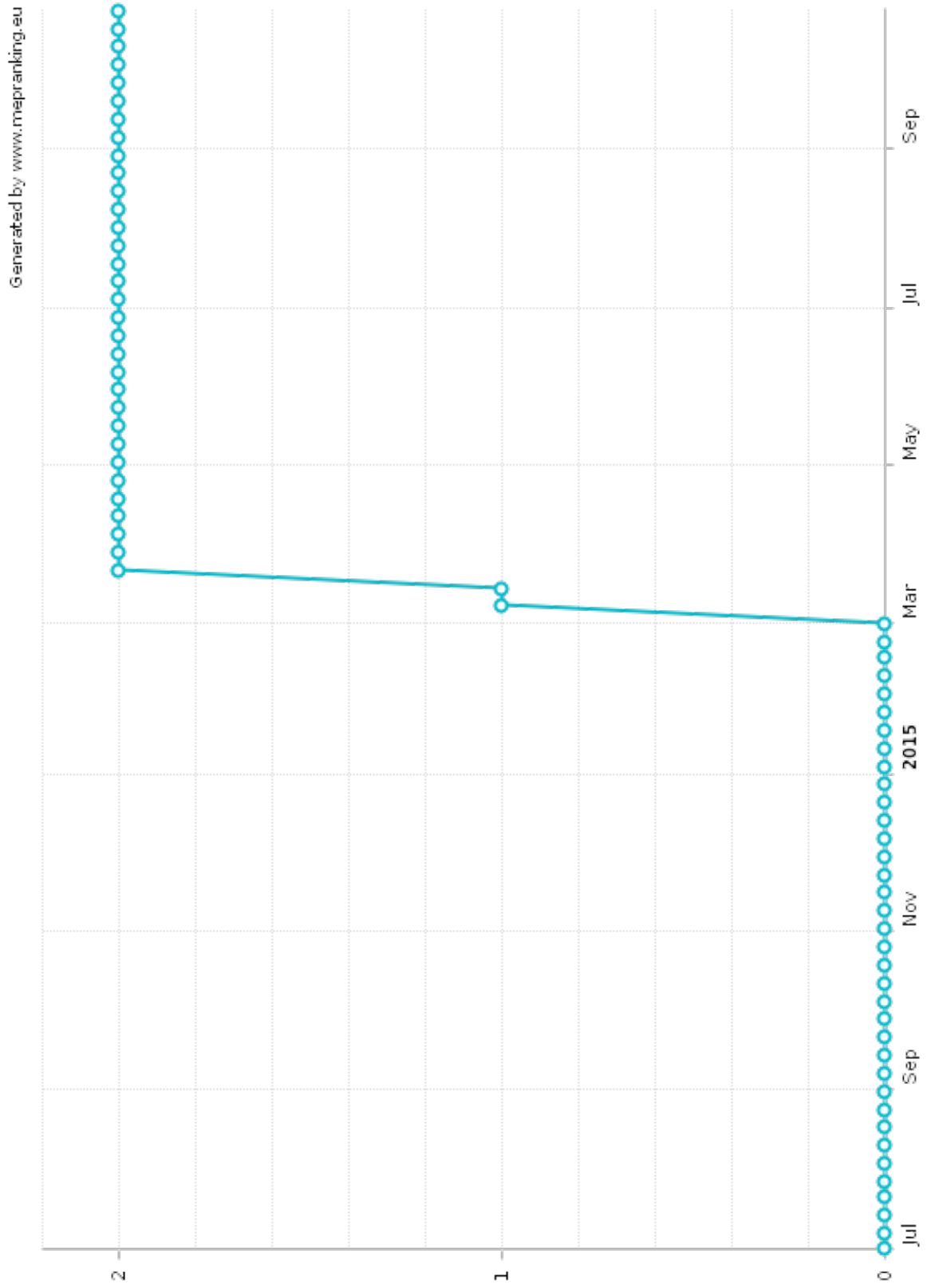

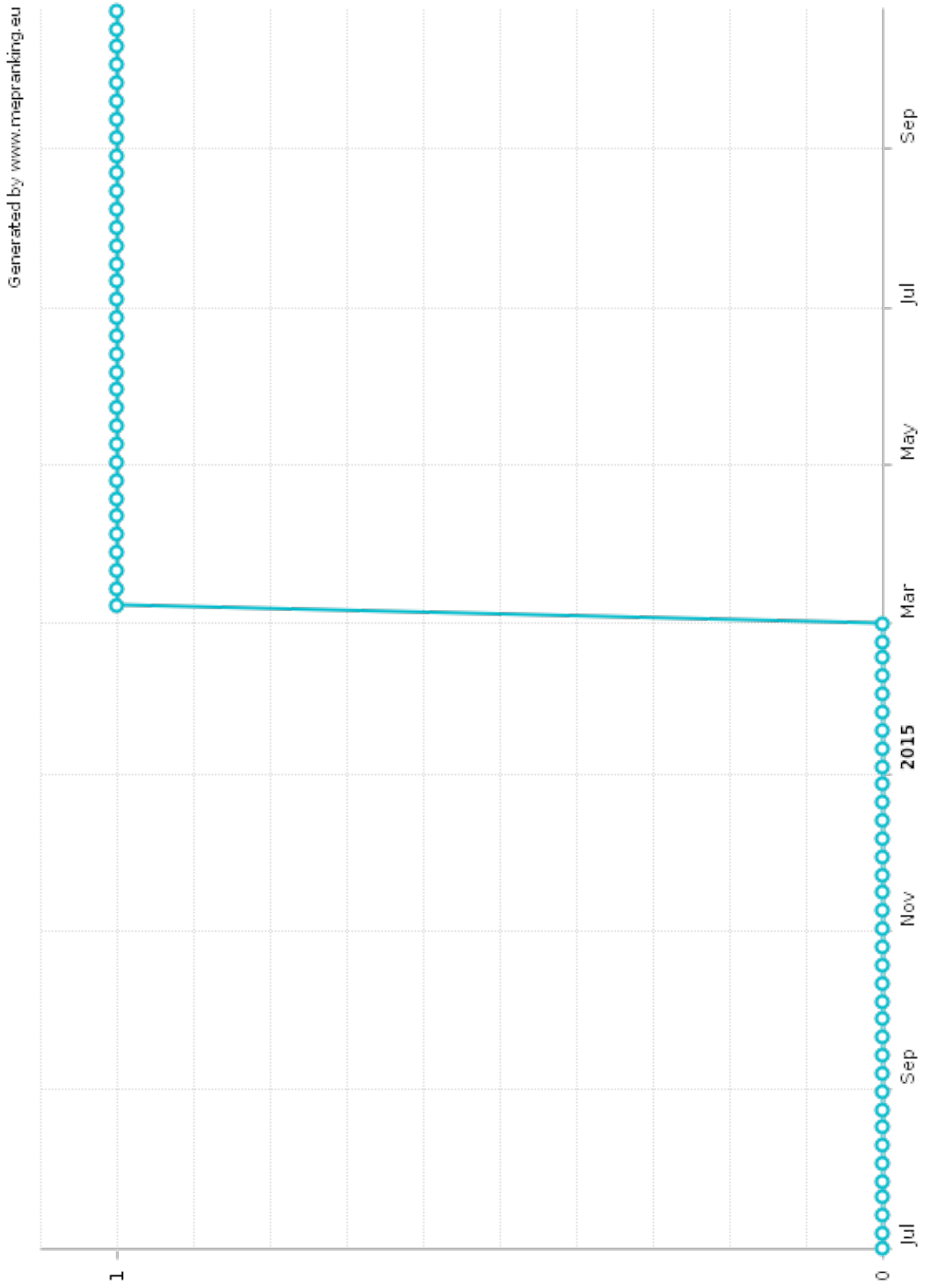
QUESTIONS of Richard SULÍK in the EP (8th term)



MOTIONS of Richard SULÍK in the EP (8th term)

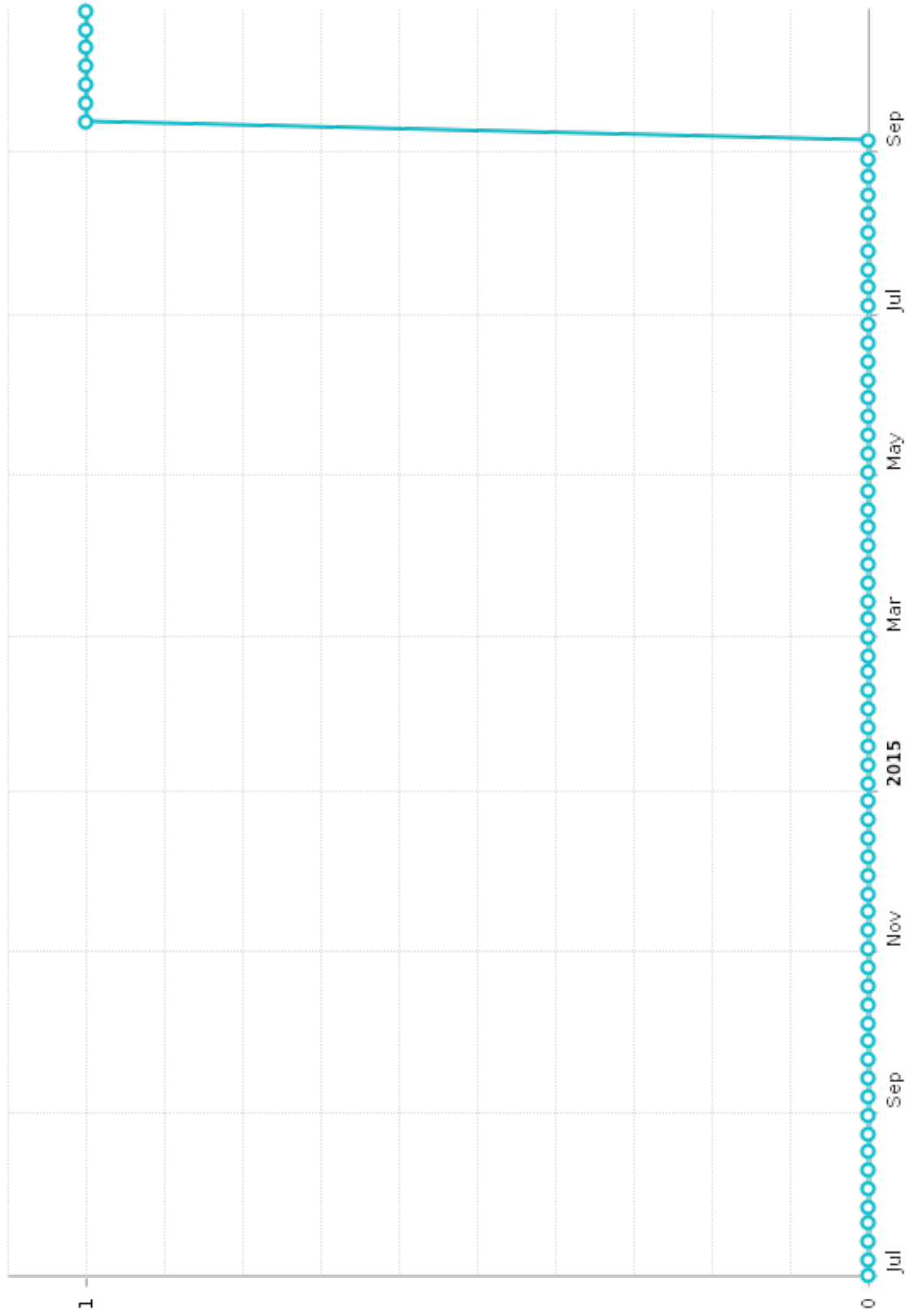

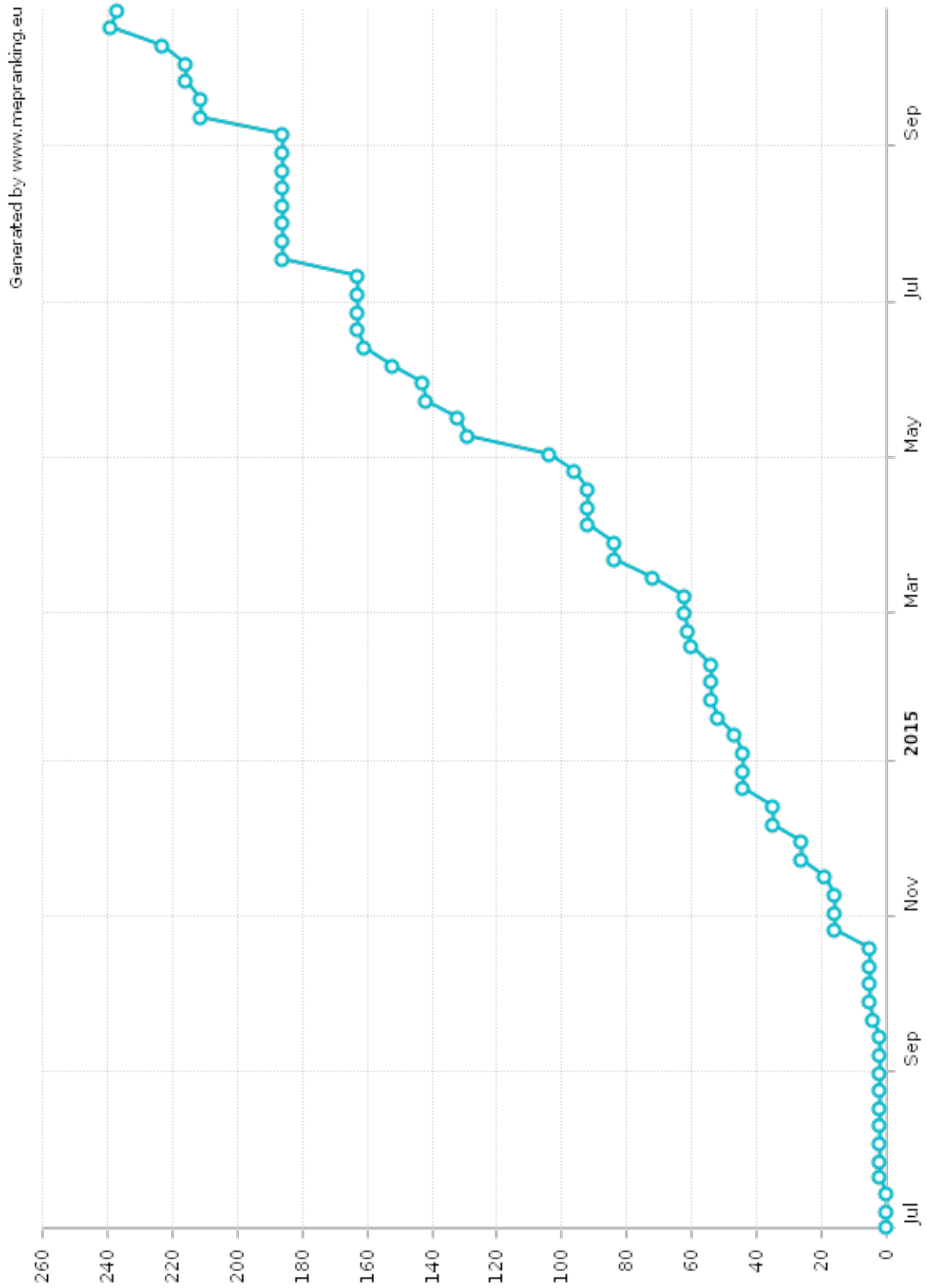

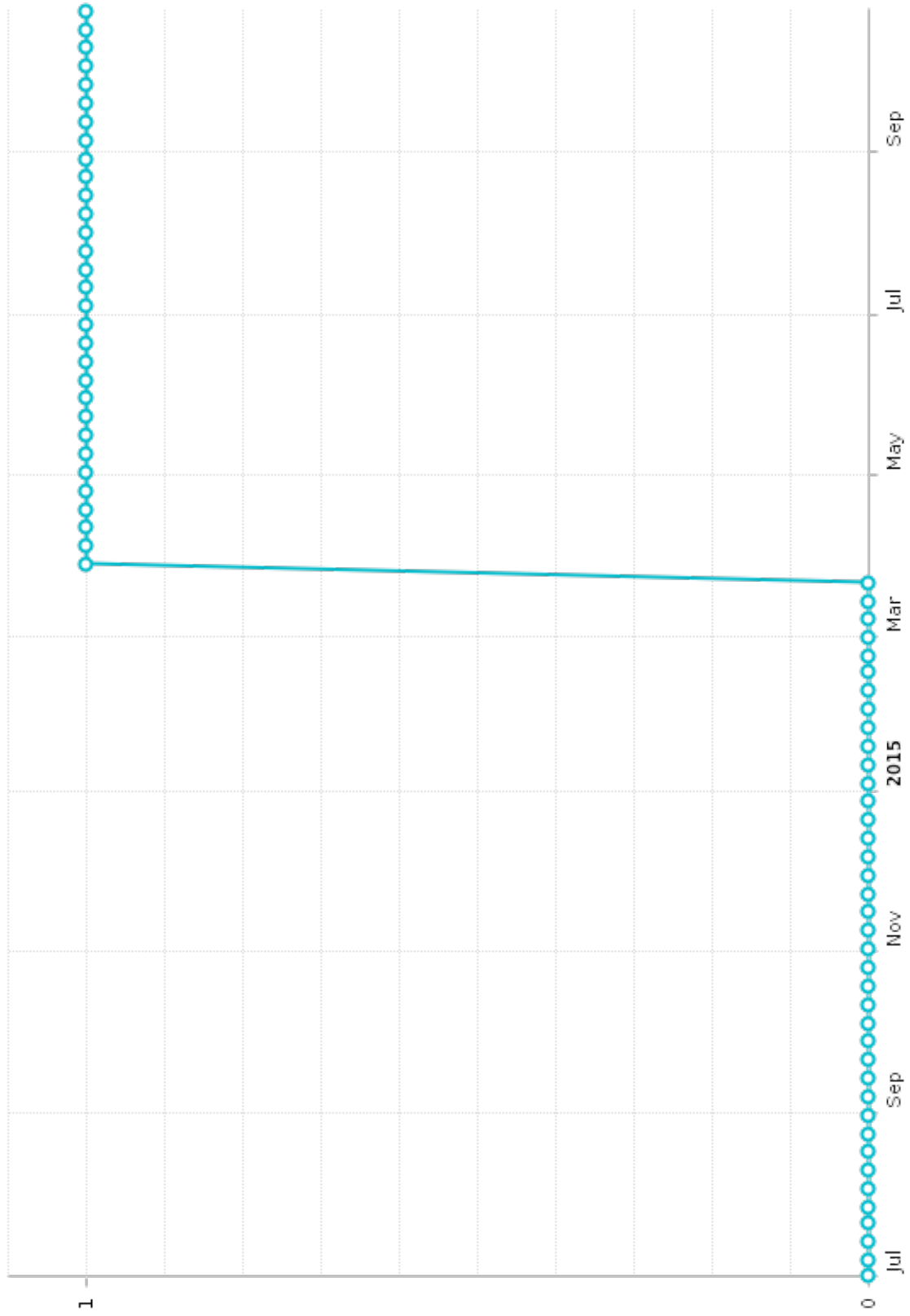


SPEECHES of Richard SULÍK in the EP (8th term)

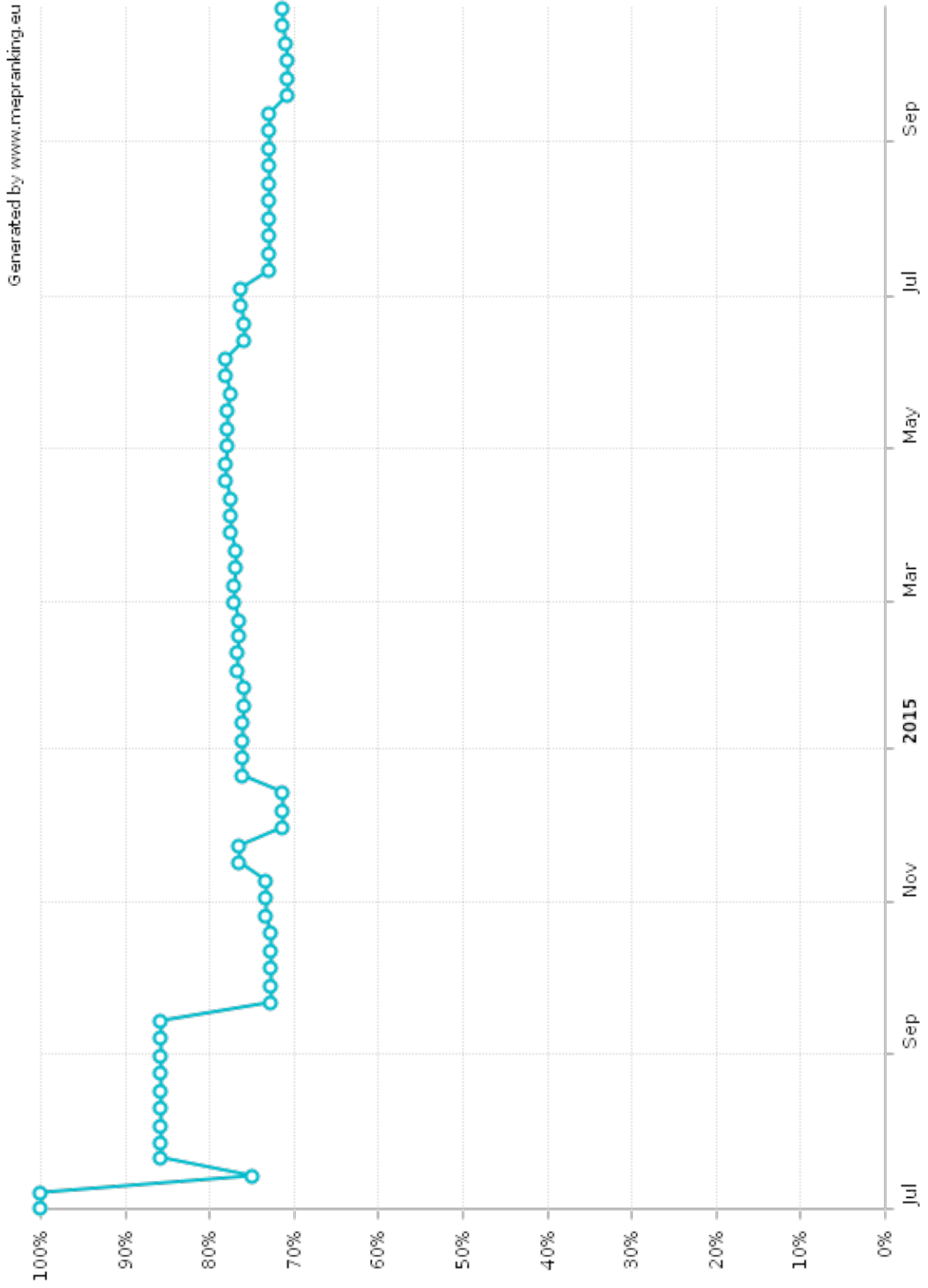

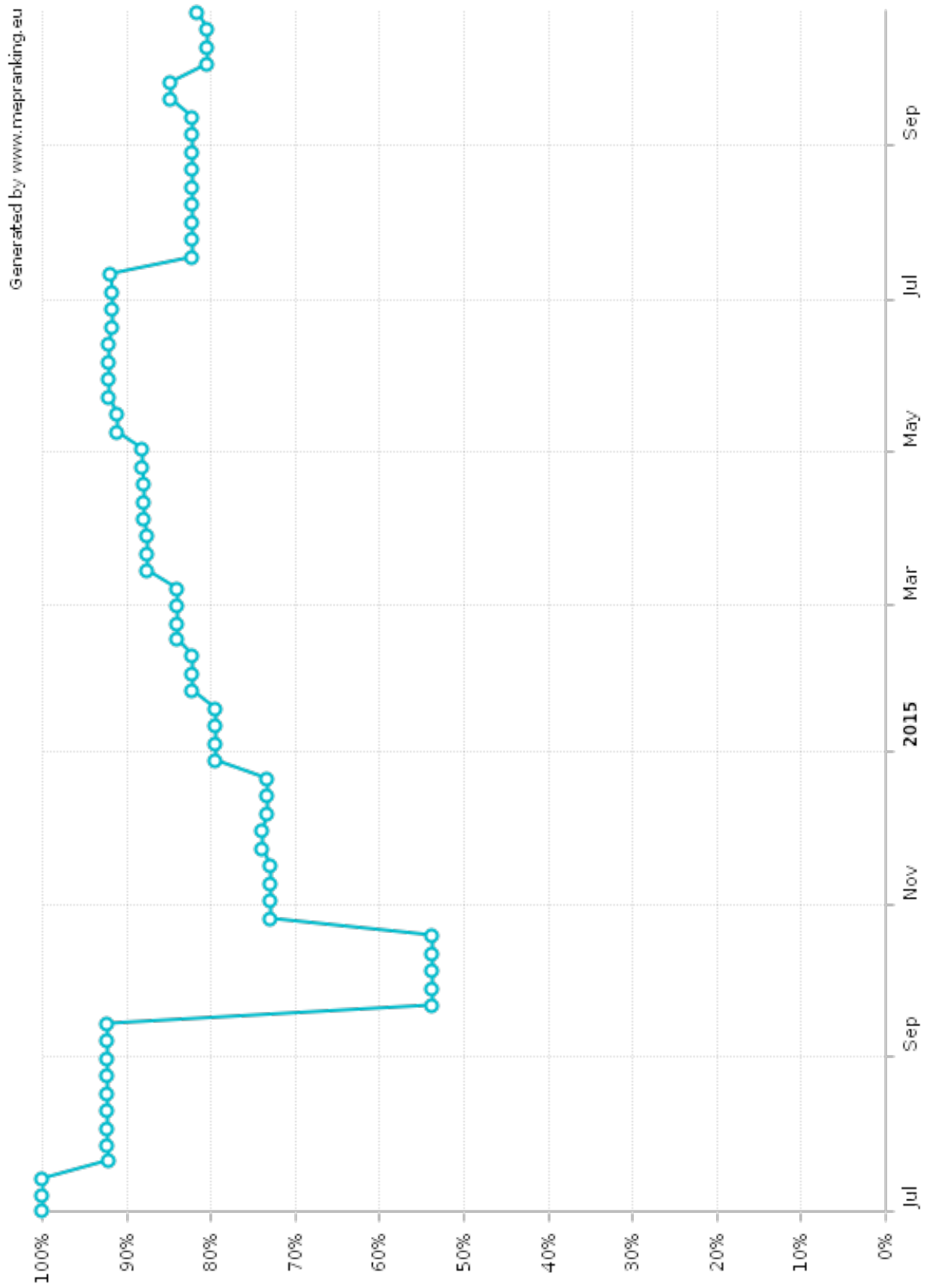
