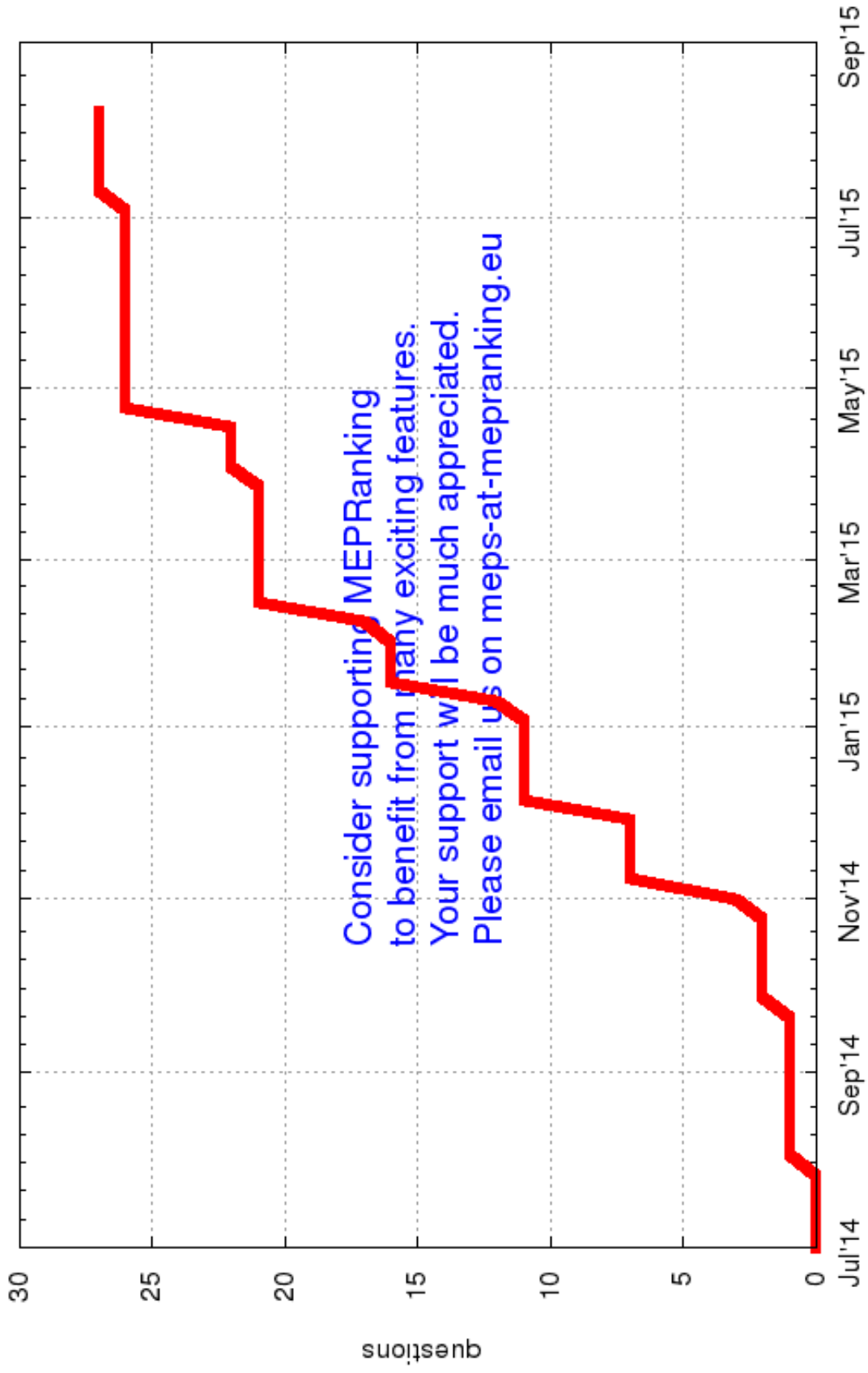

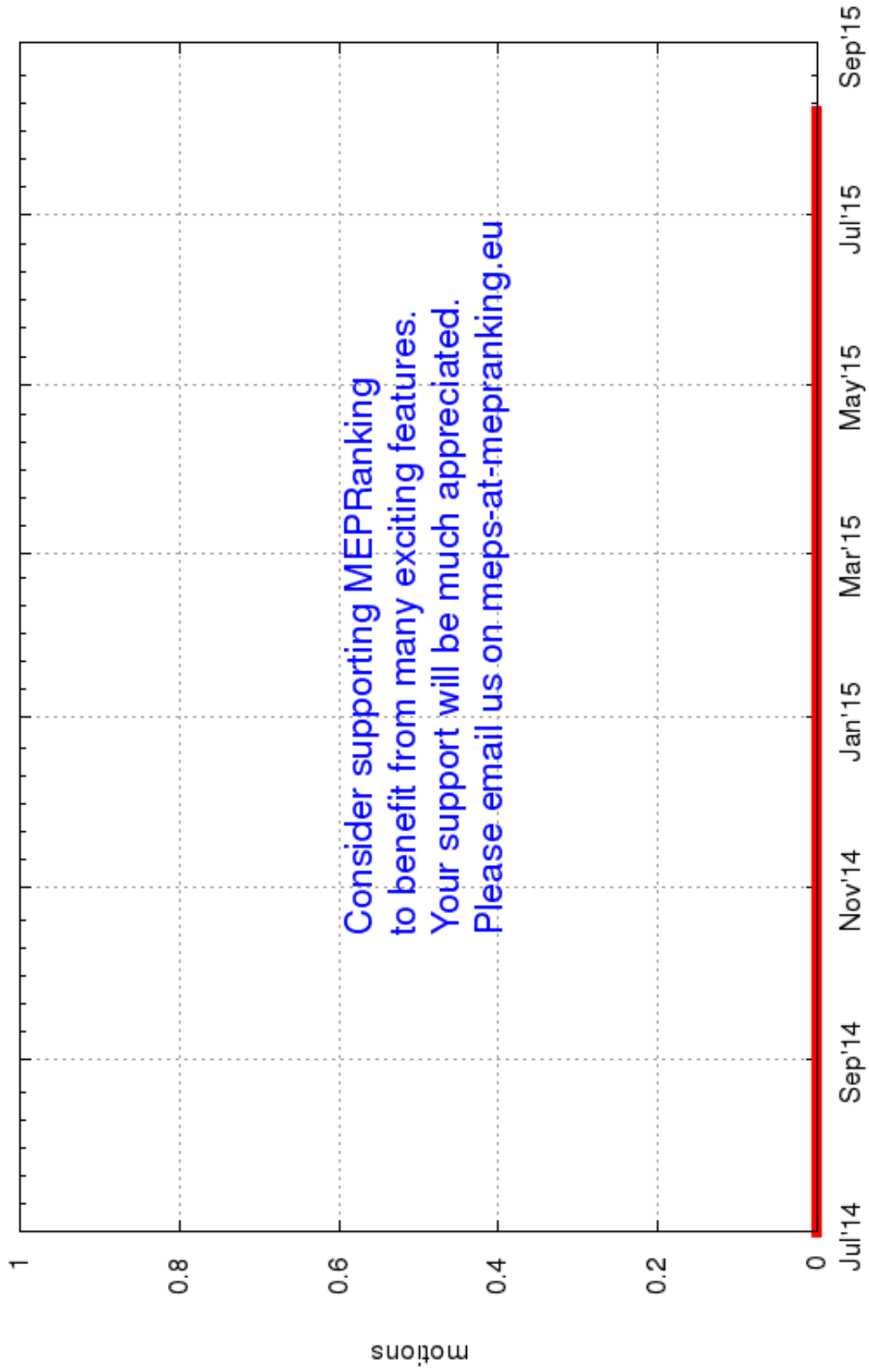

### QUESTIONS of Claudia SCHMIDT in the EP (8th term)



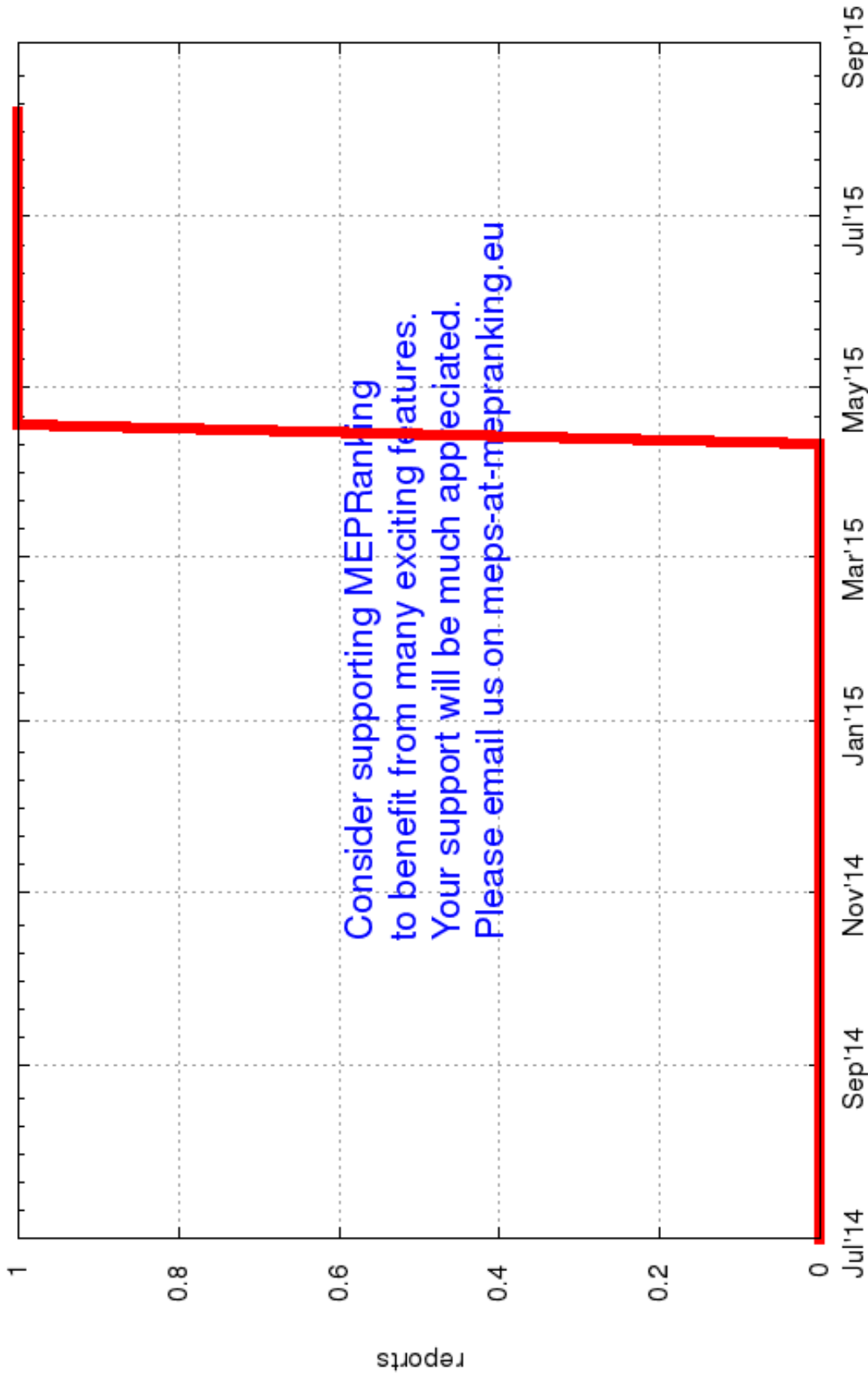

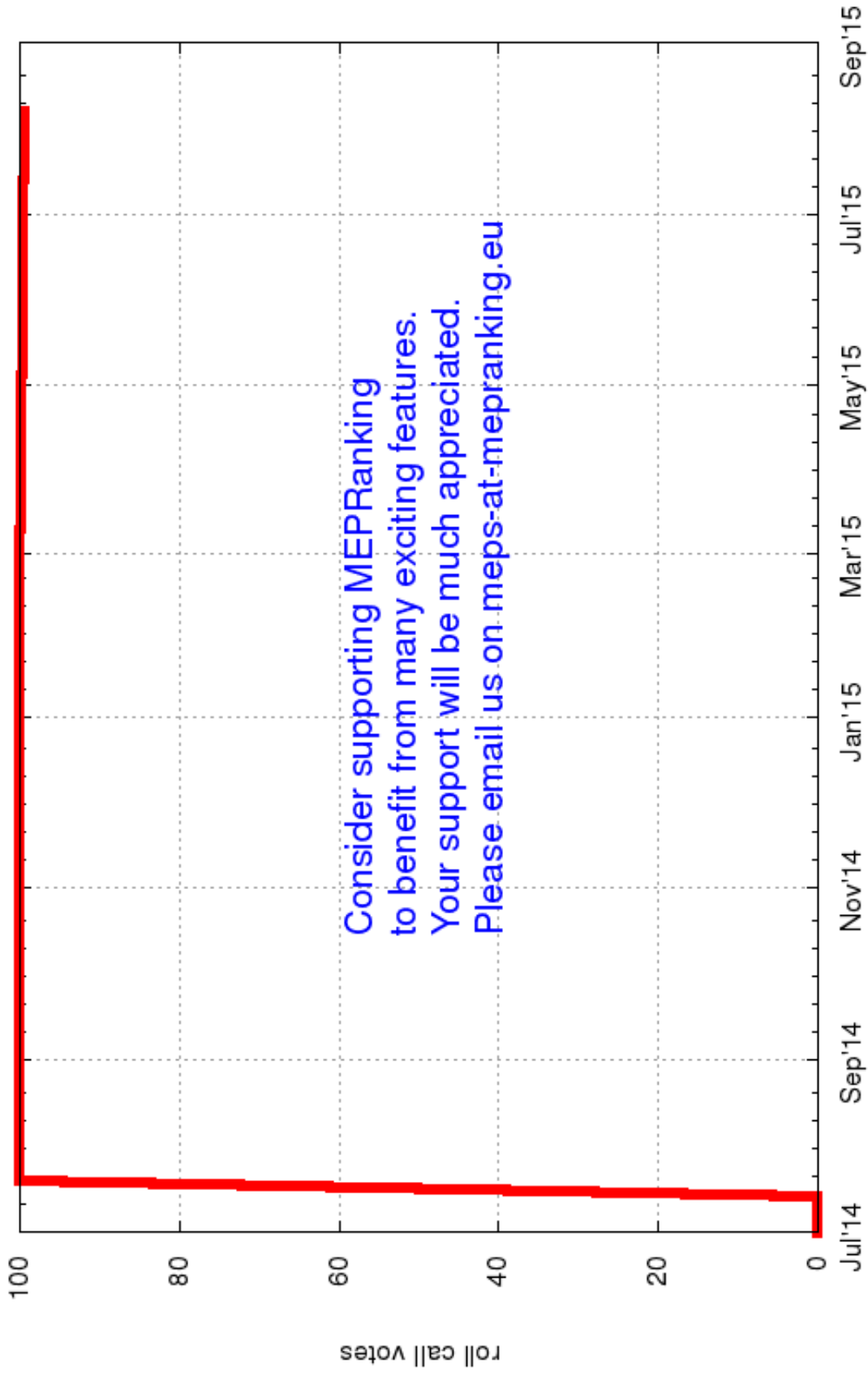
