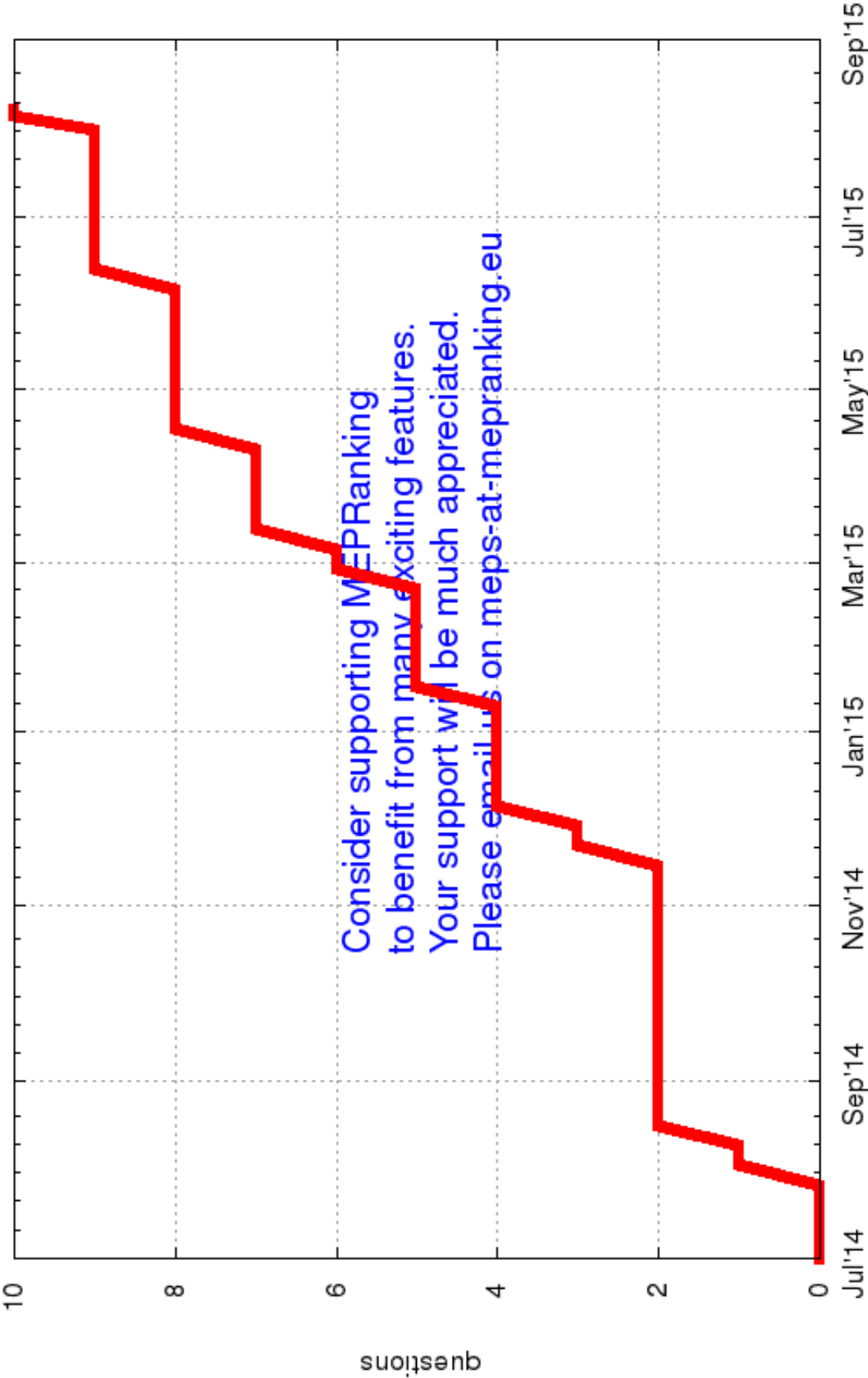

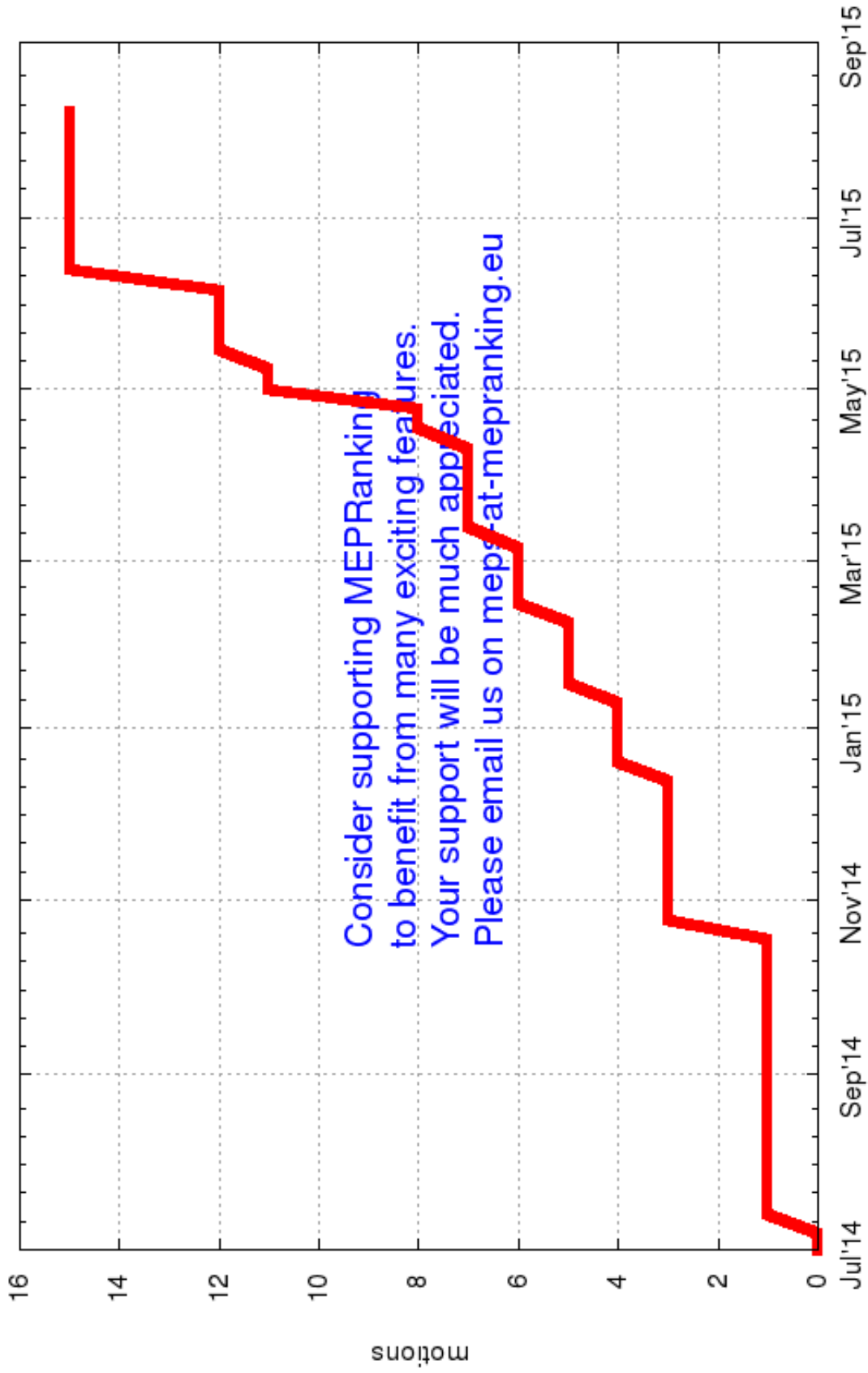

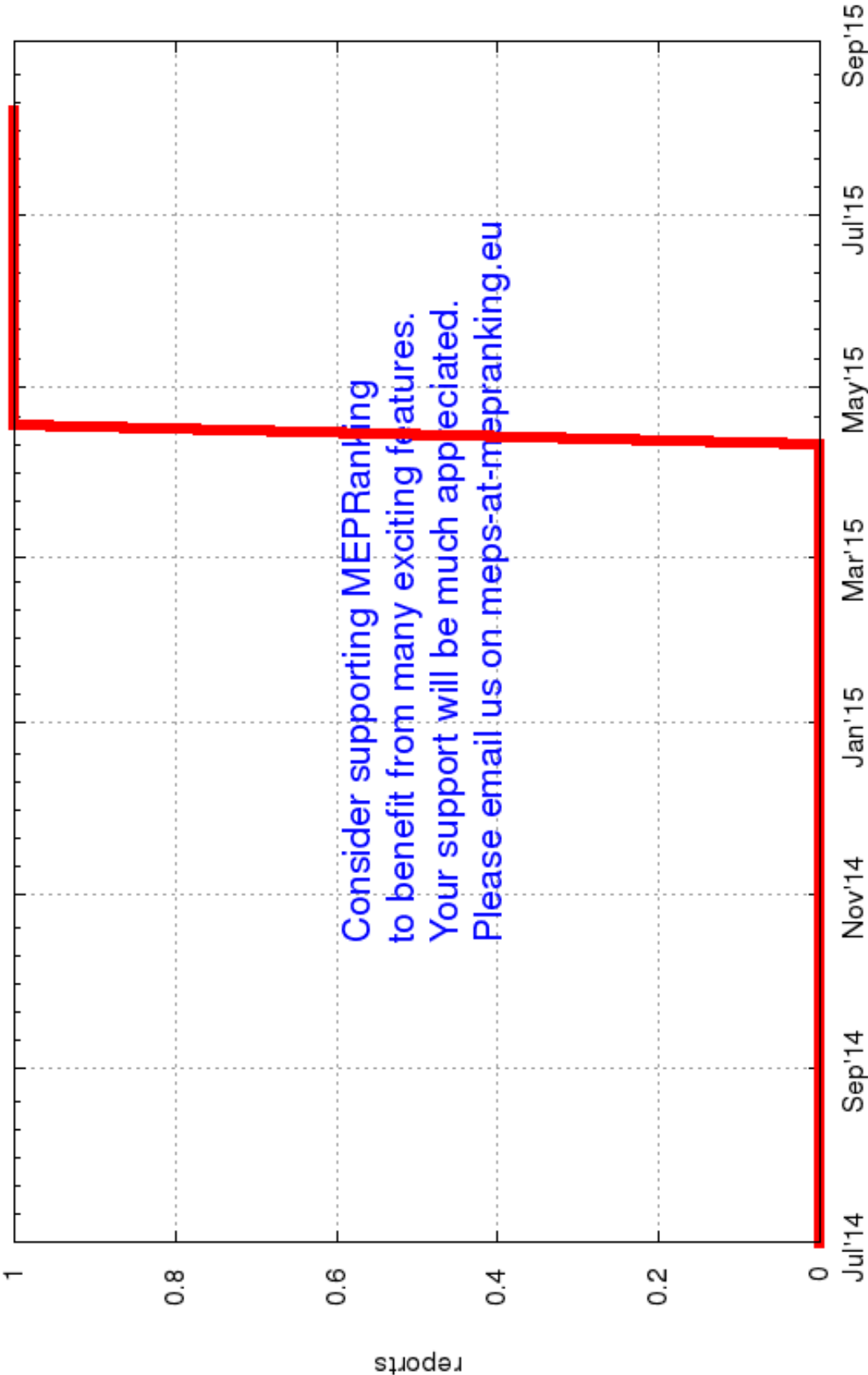
QUESTIONS of Helga TRÜPEL in the EP (8th term)



MOTIONS of Helga TRÜPEL in the EP (8th term)

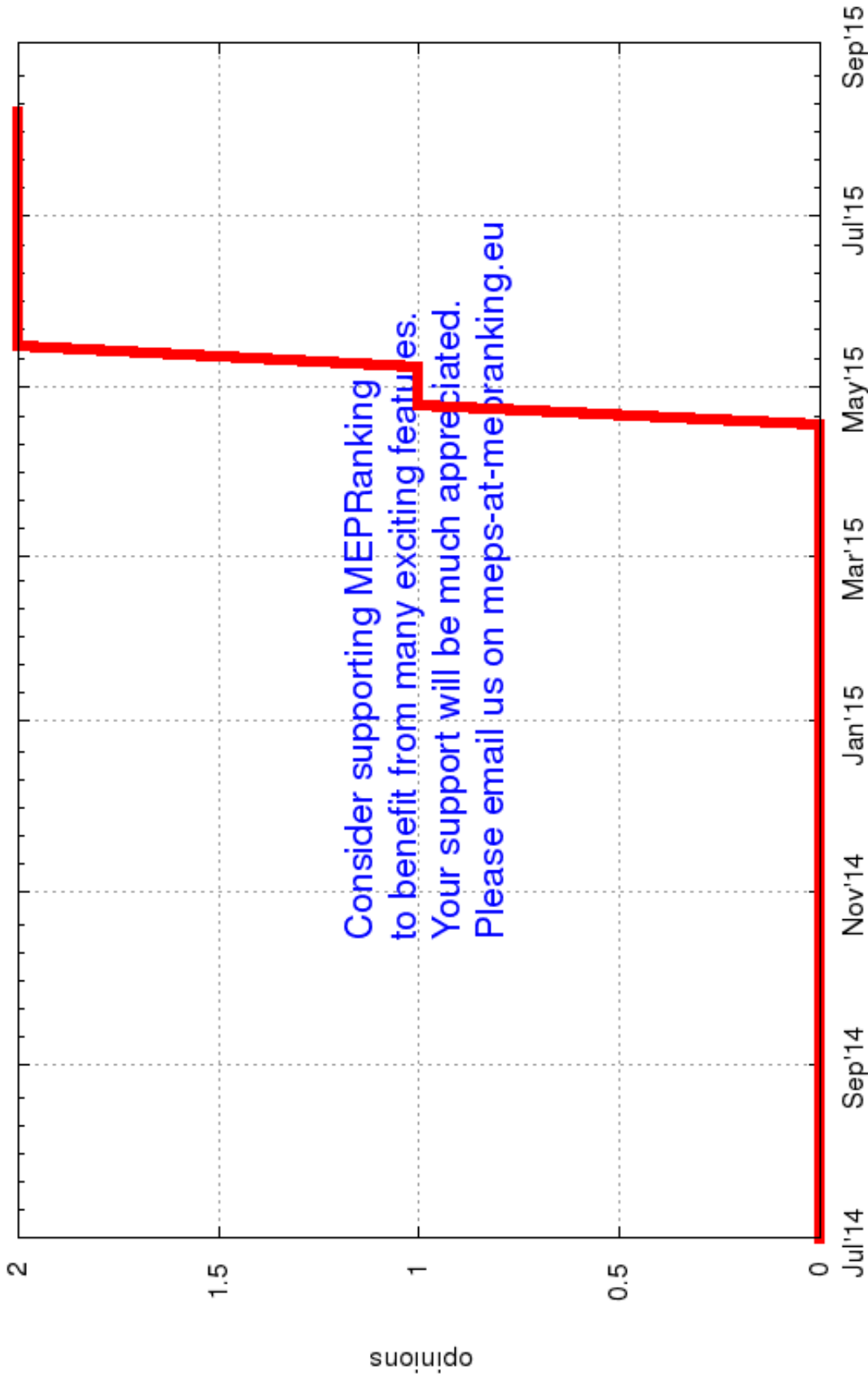

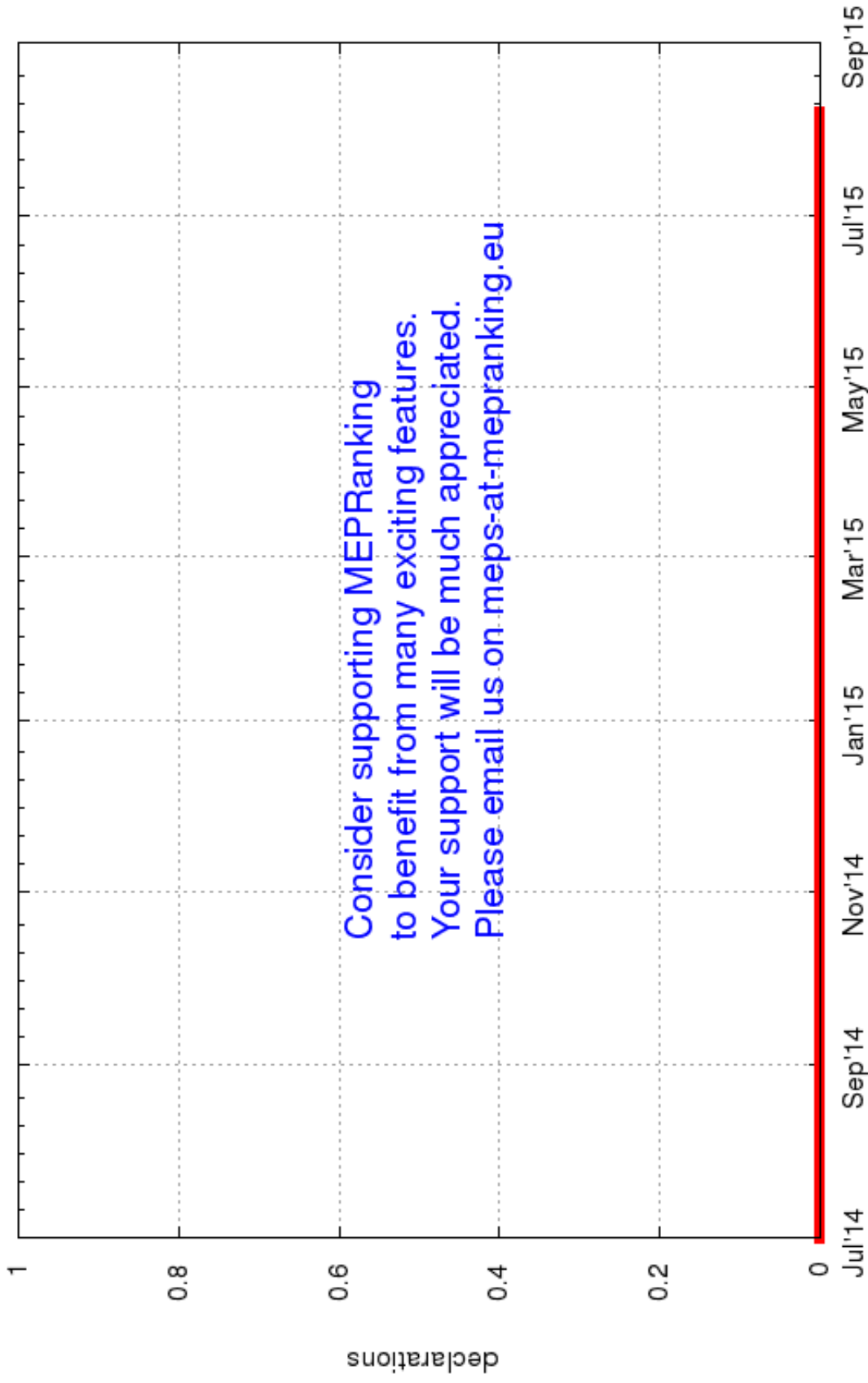

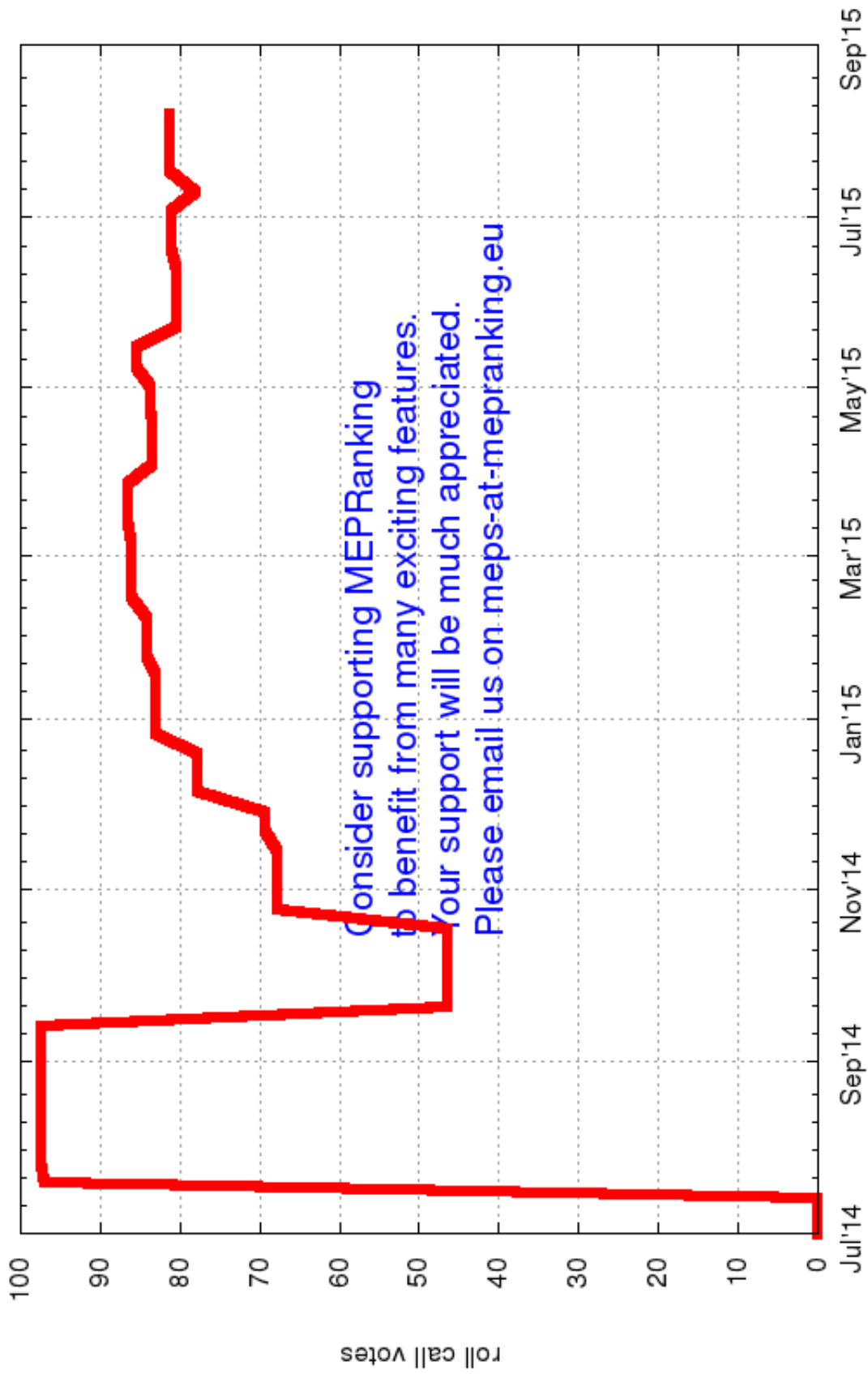
