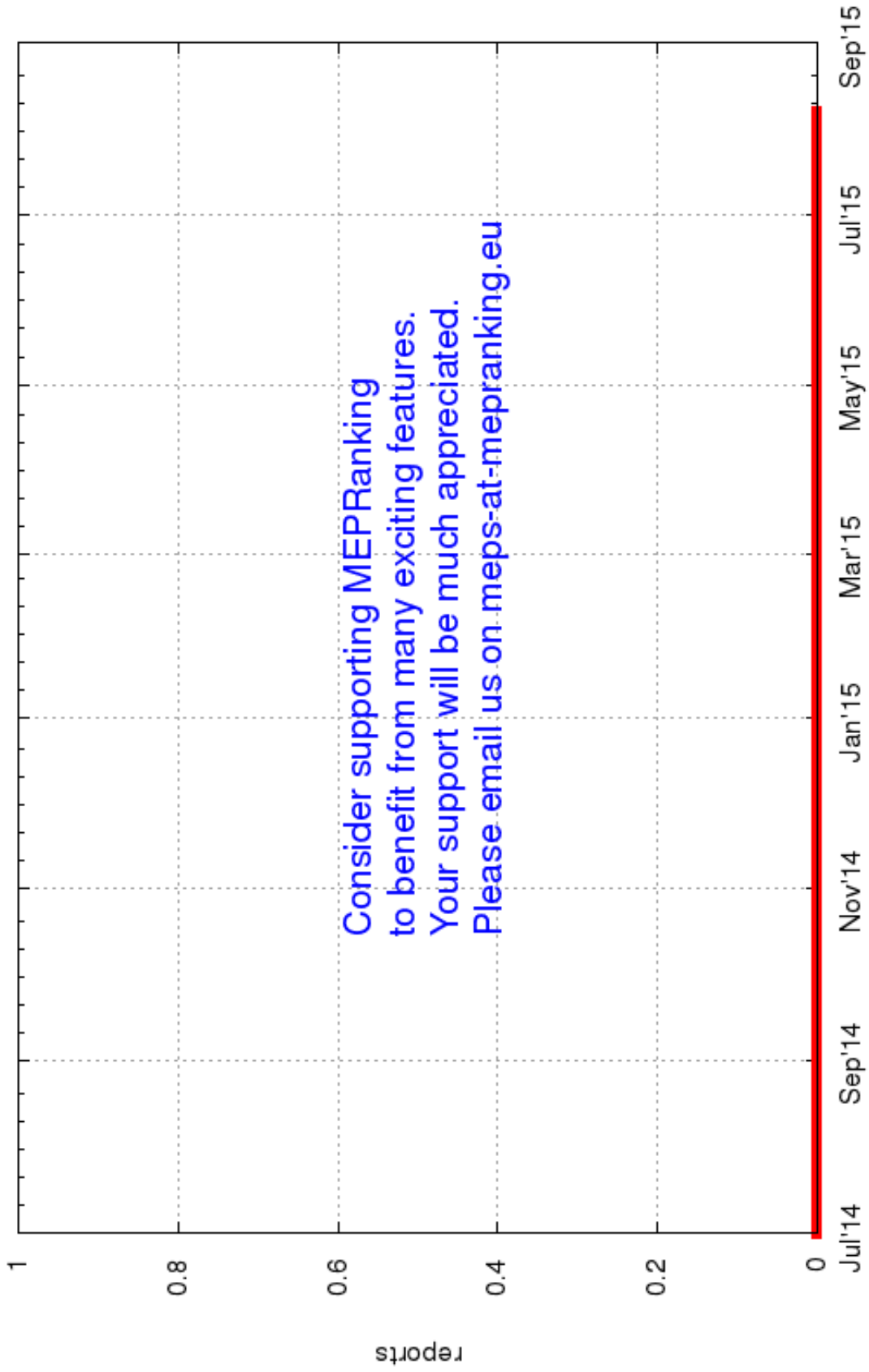

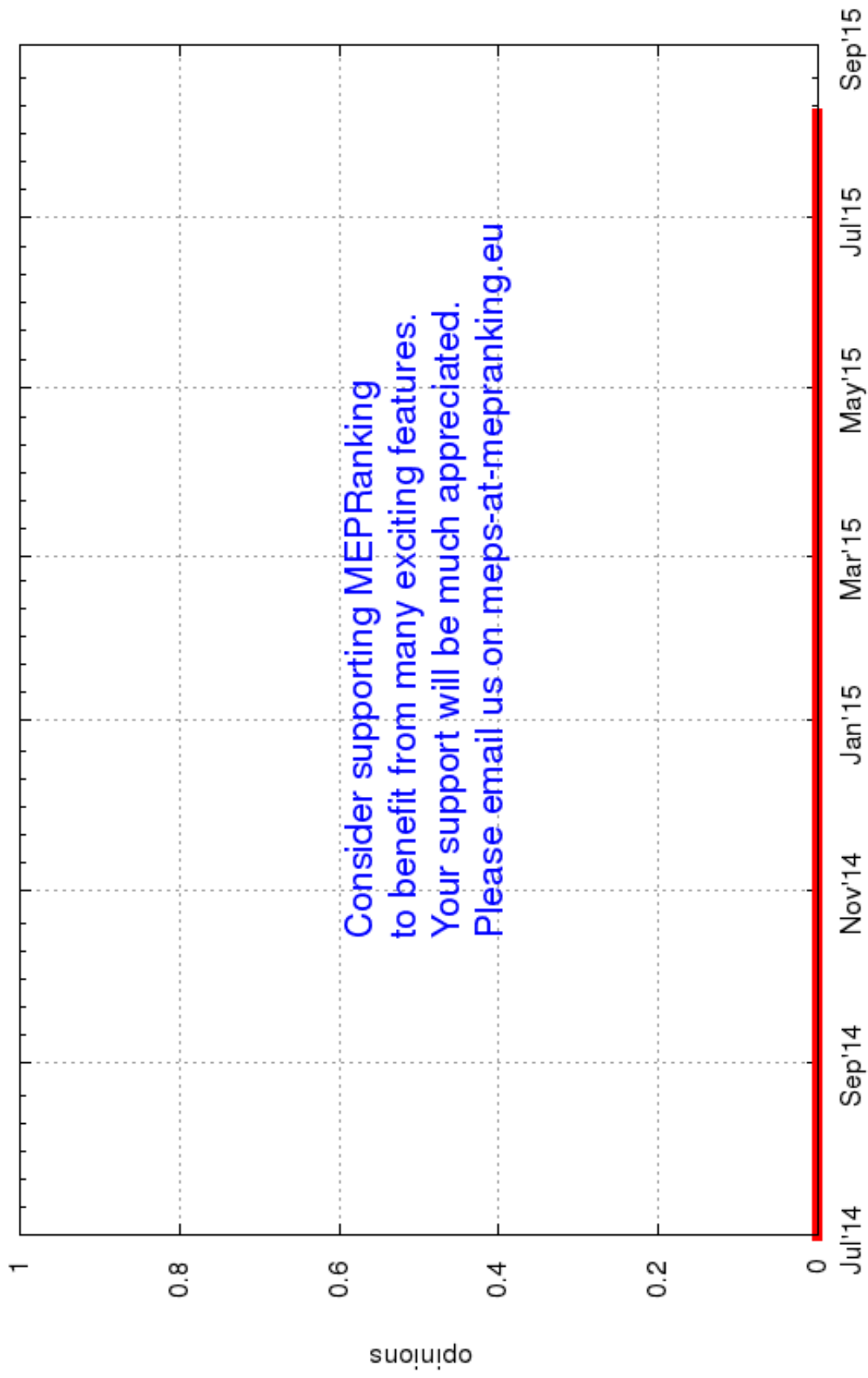
MOTIONS of Philippe JUVIN in the EP (8th term)

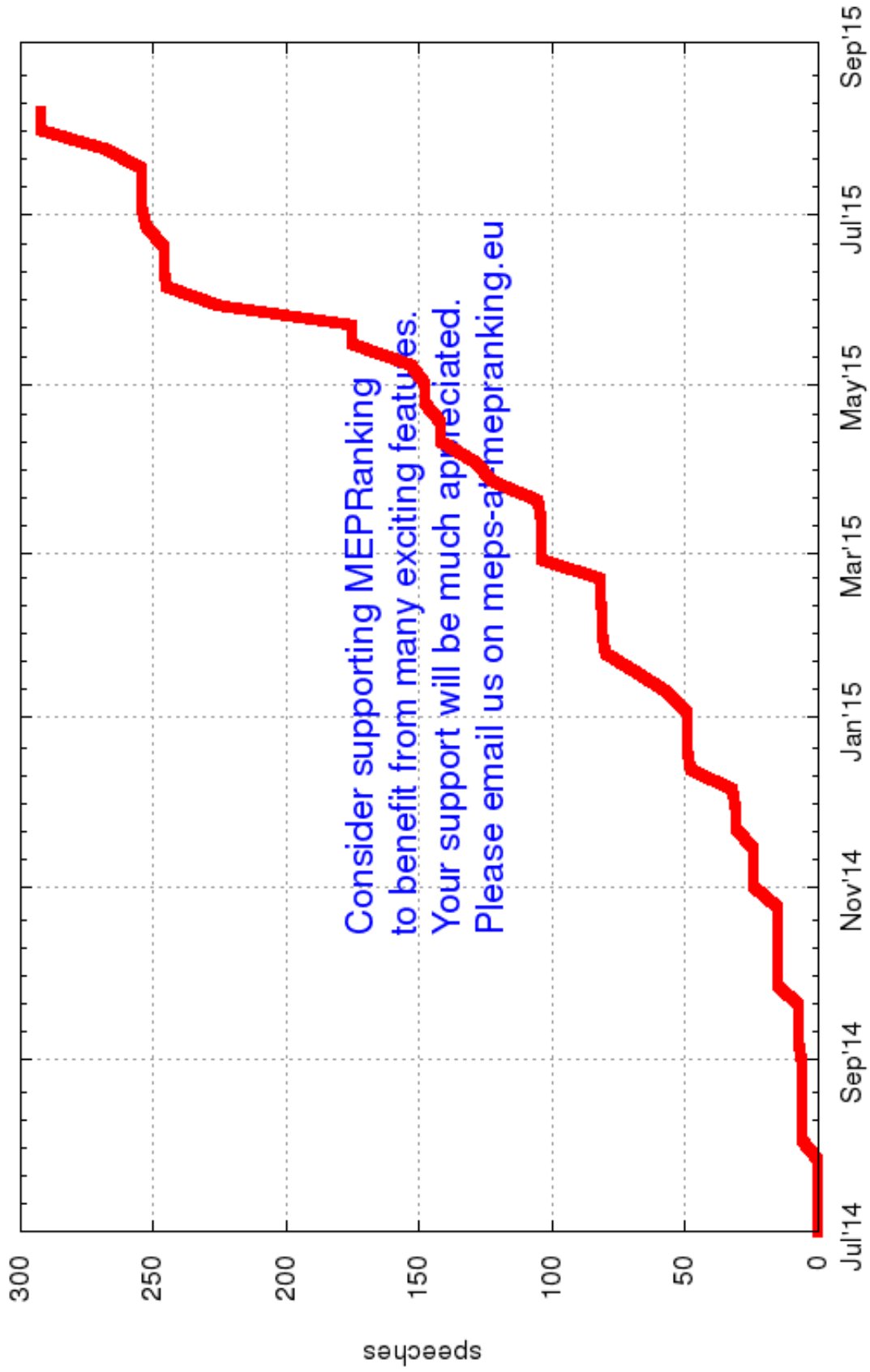

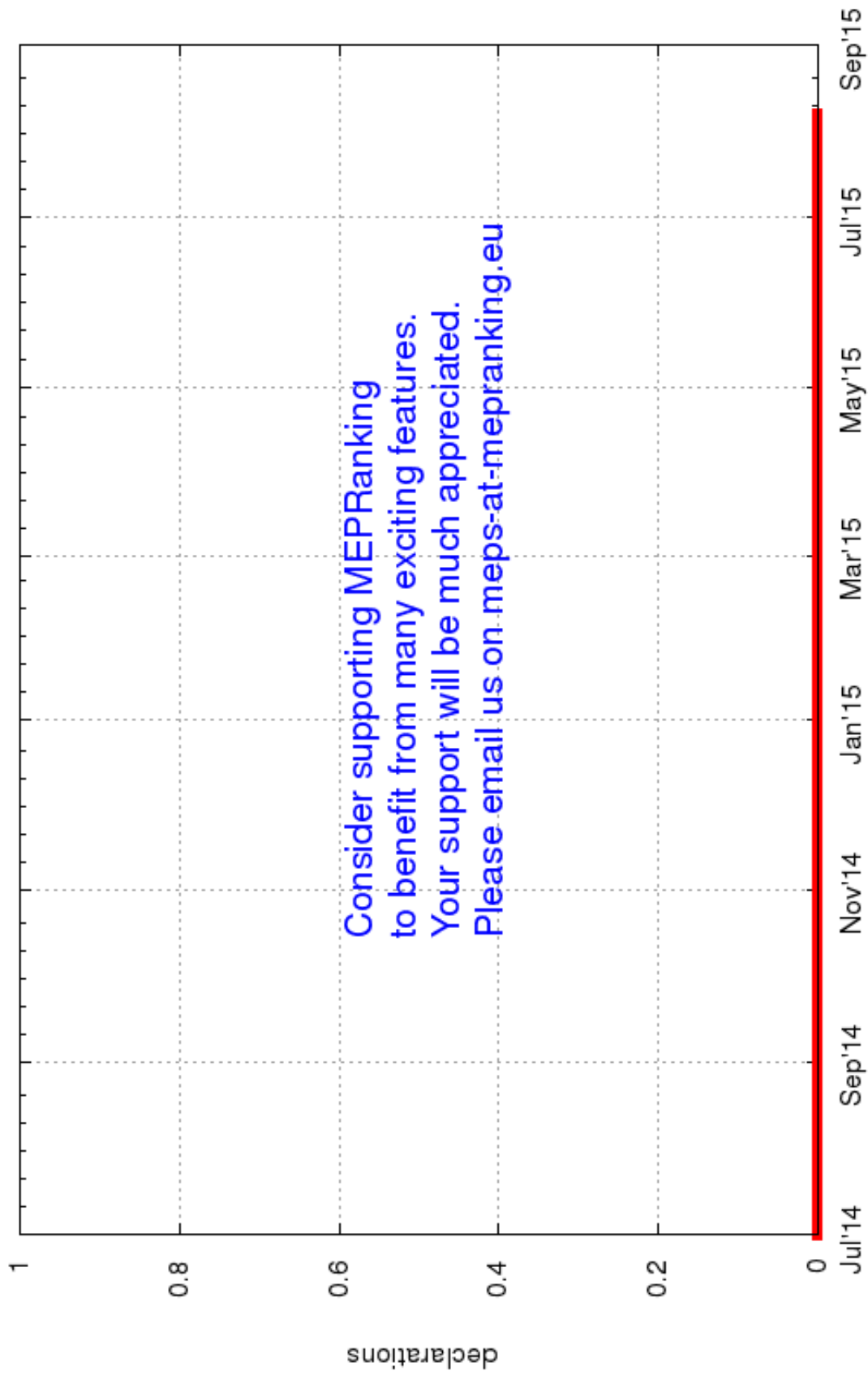

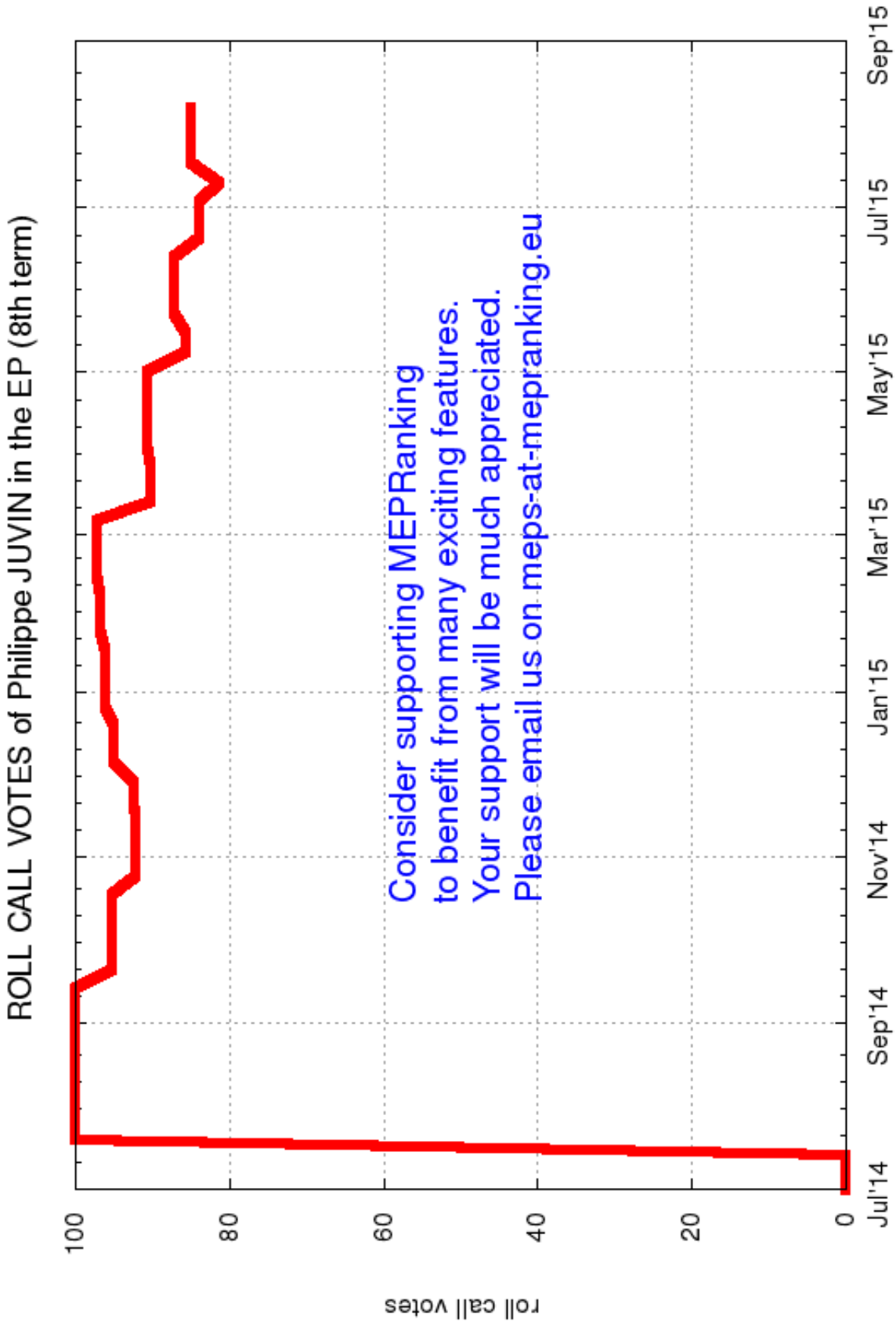
